COUNT 1: POSSESSION OF CDS MARIJUANA WITH INTENT TO DISTRIBUTE ~ 63 O.S. §

2-401(A) (1), a FELONY

COUNT 2: POSSESSION OF CDS MARIJUANA WITHOUT TAX STAMP AFFIXED ~ 68 O.S. §

450.8(B), a FELONY

STATE OF OKLAHOMA, COUNTY OF CRAIG:

I, Janice Steidley, the undersigned District Attorney of said County, in the name and by the authority, and on behalf of the State of Oklahoma, give information that in said County of Craig and in the State of Oklahoma, **DARLENE MAYES**, did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

COUNT 1: POSSESSION OF CDS MARIJUANA WITH INTENT TO DISTRIBUTE ~ a FELONY, on or about the 9th day of April, 2012, by knowingly and intentionally possessing Marijuana a controlled dangerous substance in Schedule I of the Uniform Controlled Dangerous Substances Act of Oklahoma, with the intent to distribute the same.

This crime is punishable by imprisonment for 2 years to Life and/or a fine of up to \$20,000.

COUNT 2: POSSESSION OF CDS MARIJUANA WITHOUT TAX STAMP AFFIXED ~ a FELONY, on or about the 9th day of April, 2012, by possessing, a controlled dangerous substance in Schedule I of the Uniform Controlled Dangerous Substances Act of Oklahoma without affixing the appropriate tax stamp.

This crime is punishable by up to 5 years imprisonment or a fine of \$10,000 or both.
