For those states in which your agency holds a certificate of authority (corporate qualification); certain filings are required on an annual or biennial basis. Failure to file these reports in a timely manner can result in penalties and interest, loss of good standing and revocation of the client's certificate of authority to do business.

Extensions

ILSA files extensions with the Departments of Revenue to buy you time to file your Secretary of State corporate tax returns, thereby avoiding fines and penalties.

Withdrawing Corporate Qualification

If you no longer do business within a state, ILSA can prepare and submit withdrawals to the Secretary of State to retract your registration.
