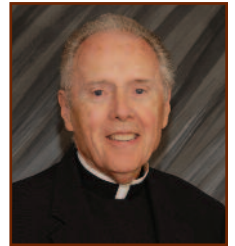


VINCENT CULLEN, CPA


