19 I, Beatrice Pacheco, hereby declare and state to the following:

21 1. That I am the Conservatee in the above caption, and I present
22 this declaration with sound mind and voluntarily, based on my wishes to
23 begin to undo what has so unjustly been done to me by Stephen Pacheco
24 and Michael Desmarais.

1 2. I have consistently spoken to this court's examiner, lawyers,
2
3 my son and others regarding my estate and marriage to Marreon Gene
4 Starks ("Gene").

6 3. I have clearly expressed to them each that I have a clear mind
7 and desire to make the decision to live my remaining days with Gene
8
9 precisely because he has given more happiness than I actually ever
10 experienced before with my deceased husband and otherwise.

12 4. My son Stephen has consistently shown an illogical hatred
13 against Gene.

15 5. Stephen has always been a self-serving and unloving man,
16 who has no actual love towards me.

18 6. Once I learned about these conservatorship proceedings, and
19 spoke with all the actors playing their different roles in this court drama, I
20 have repeatedly asked, begged, ordered and otherwise requested for them
21 to permit me to speak with the judge directly on the record so that the
22 public record will show that I have sound mind and made the decisions to
23 be with Gene based upon my own vo

1 7. My son and Michael Desmarais are 100% against anyone who

3 does not go along with their plan to take my money and are attacking
4 anyone who is showing signs of helping me.

6 8. Michael Desmarais positively knows that I have a sound mind
7 and wish to be with Gene, and that Stephen does not have my best interest
8
9 at heart, but it appears that he has not represented to this court any of my
10 needs, wishes or what is best for me.

12 9. I have and are in a state of depression because of this forced
13 and illegal separation from Gene, which even my mental doctor is aware
14
15 of but it appears that non of this is being considered by the court.

17 10. Since I have been talking to and expressing all my wishes to
18 the court examiner, Michael Desmarais, Stephen and others, and the court
19 still issued and maintains a retraining order against my husband Gene and
20
21 I, I can only conclude that judge Cain is somehow biased against me and
22 my interests without any good factual or legal basis.

15 16. It appears that judge Cain is violating this right, and others to

23 son, and I have constantly been mentally abused.


1 19. I have a lot to say on this subject to any judge willing to hear
