- 10. I asked Ms. Hoard to notify me as to when the unedited version would be made available but I never received that information.
- 11. On December 12, 2011, I contacted Ed Butler, legal officer of the United States District Court of Colorado and asked how to go about receiving a copy of the unedited version of the transcript.
- 12. Mr. Butler told me that he talked to Ms. Martinez and Ms. Hoard and they advised him that the unedited version no longer existed.
- 13. I explained to Mr. Butler that as of November 14, 2011, when I talked to Ms. Martinez and Ms. Hoard, they advised me that the unedited version was available but Ms. Martinez was not releasing the unedited version at her discretion once the edited version was made available. I further informed Mr. Butler that Ms. Hoard advised that the unedited version was available for \$3.05 per page.
- 14. I asked Mr. Butler had the unedited version now been destroyed. He advised no nothing had been destroyed and suggested I file a motion to request a copy of the unedited version.
