A fully accredited, private, undergraduate university on a picturesque 30-acre campus at the foot of the scenic Ozark Mountains in Clarksville, Ark., some 100 miles west of Little Rock, University of the Ozarks is consistently rated among the top institutions of higher education in the region by publications and surveys including U.S. News & World Report.

Founded in 1834, University of the Ozarks was one of the first co-educational schools west of the Mississippi River. It was also the first in Arkansas to admit women and the state's first historically white college to graduate an African-American and to integrate intercollegiate sports.

Throughout its long and storied history, the university has consistently provided personal, creative, student-oriented

innovation in private education while preserving a history of dedication to Christian values and service.

This spirit of innovation led the university to purchase **CAMS DOS** in 1996 when it found Jenzabar's Poise was no longer a good match. 

University of the Ozarks was founded in 1834 by Cumberland Presbyterians as Cane Hill School at Cane Hill, Ark., located in northwest of the state. In 1891, Cane Hill College closed operations and its successor Arkansas Cumberland College was established in Clarksville, Ark. In 1920, the name was changed to The College of the Ozarks, and in 1987 the school was renamed to University of the Ozarks. The University has always had a relationship with the Presbyterian Church. At one time the college was under the ownership of the Oklahoma-Arkansas Synod of the United Presbyterian Church (USA). In 1960, the Board of National Missions of the United Presbyterian Church (USA) assumed ownership and operating responsibility for the college. In 1973 an elected board of trustees assumed administrative responsibility and ownership.
