ABOUT THE LECTURE

Providing adequate care for co-occurring PTSD and addiction is a difficult challenge beyond the application of evidence-based protocols or use of the latest techniques. Clinicians who treat this population need to be tenacious, articulate, compassionate and have superb boundaries. They also need to be absolutely clear as to the actual goals and sequence required. This brief workshop will review the necessary foundations for understanding the scope and nature of PTSD as it co-occurs with addiction. In addition, attendees

will be introduced to a multi-dimensional model that can assist in managing the volatile and complex challenges of treating veterans and civilians who struggle with their recovery.

COURSE OBJECTIVES

- 1. Attendees will review some simple phrases, definitions and descriptions that capture the core symptoms and clinical priorities needed to treat PTSD with co-occurring conditions.
- 2. Attendees will be given an overview of some of the challenges faced by clinicians including: accurate clinical expectations, proper sequence and priorities of treatment, the need for containment, rapid synthesis, attitudinal factors, enhancing the clinical alliance, and the need for proper pacing and self care in dealing with perhaps the most challenging patient population we face.
- 3. Attendees will be introduced to a multidimensional model that will help them transcend the narrow focus that can undermine our best efforts in assisting these complex cases.

Dr. Jerry Boriskin is an author, lecturer, and clinician with an expertise in trauma, post-traumatic stress disorder (PTSD) and addictive disorders. He began his career in 1979 when PTSD began to emerge as a diagnosis. In the mid-1980's, he began working with addicts and sexual abuse survivors. Dr. Boriskin is a leader in extending the continuum of care and has developed two extended residential treatment programs for co-occurring disorders. As a passionate advocate for integrated treatment, Dr. Boriskin is a licensed psychologist and addiction specialist who has been working with traumatized soldiers at the V.A. of Northern California.
