


Each of us is now more than 18 years of age and a competent witness and resides at the address set forth after her name.

LAST WILL AND TESTAMENT

OF

L'WREN SCOTT

I, L'WREN SCOTT, born LU ANN BAMBROUGH, a resident of New York, and a citizen of the United States of America, declare that this is my Will.

FIRST: I revoke all Wills and Codicils that I have previously made.

SECOND: I have ~~never~~ been married. I have no children.

THIRD: I give all my jewelry, clothing, household furniture and furnishings, personal automobiles and other tangible articles of a personal nature, or my interest in any such property, not otherwise specifically disposed of by this Will or in any other manner, together with any insurance on the property, to Michael Philip Jagger.

FOURTH: I give the rest and residue of my estate to Michael Philip Jagger.

FIFTH: Except as otherwise provided in this Will, I have intentionally omitted to provide herein for any of my heirs living at the date of my death.

SIXTH: I nominate Adam Glassman as Executor of this Will, to serve without bond.

a. I authorize my Executor to sell, with or without notice, at either public or private sale, and to lease any property belonging to my estate, subject only to such confirmation of court as may be required by law. I further authorize my Executor, on any preliminary or final distribution of the property in my estate, to partition, allot, and distribute my estate in kind, including undivided interests in my estate or any part of it, or partly in cash and partly in kind, or entirely in cash, in my Executor's absolute discretion.

b. I further authorize my Executor either to continue the operation of any business belonging to my estate for such time and in such manner as my Executor may deem advisable and for the best interests of my estate, or to sell or liquidate the business at such time and on such terms as my Executor may deem advisable and for the best interests of my estate. Any such operation, sale or liquidation by my Executor, in good faith, shall be at the risk of my estate and without liability on the part of my Executor for any resulting losses.

SEVENTH: I have not entered into a contract to make this Will, nor any contract that would limit my right to amend or revoke it, so that I retain the absolute right to amend or revoke this Will at any time and in any circumstances.
