Oxygen Forensic Suite 2014: Data Acquisition from My Windows Phone

Oxygen Forensics updates its flagship mobile evidence discovery solution, Oxygen Forensic Suite 2014, enabling data acquisition from My Windows Phone cloud. The new release enables investigators to acquire the content of Windows Phone mobile devices stored in Windows cloud (login and password required).

The addition of data acquisition from My Windows Phone Cloud expands the list of available data sources in Oxygen Forensic Suite 2014. While the original Windows Live account credentials are required to have an access to the content from the cloud service, Oxygen Forensics becomes industry first to acquire contacts and messages of Windows Phone devices.

Remote Data Acquisition via My Windows Phone

The latest release of Oxygen Forensic Suite 2014 enables remote data acquisition of mobile devices running on the popular Windows Phone platform. The acquisition technology has been licensed from ElcomSoft Co. Ltd., making Oxygen Forensic Suite 2014 the first analytic package on the market to receive remote access to information contained in My Windows Phone (previously Windows Phone Live) cloud. The original Windows Live account credentials are required to obtain information from the cloud. However, physical access to the original Windows Phone device is not needed. Available data includes contacts, messages and general device information.

Even having the correct My Windows Phone credentials, experts who are not equipped with Oxygen Forensic Suite will be unable to access most information stored in the cloud. My Windows Phone cloud stores information in a complex format, making manual forensic analysis of this data complicated and practically unfeasible. On the other hand, Oxygen Forensic Suite will extract, parse and classify every bit of user data stored in the cloud.

The addition of My Windows Phone Cloud to the list of available data sources enables the users of Oxygen Forensic Suite to do the following:

- Acquire information stored in My Windows Phone accounts directly (login and password required)
- Physical Windows Phone device is not required to acquire or decrypt the data
- Acquire and parse Contacts and Messages
- Use all the powerful analytic features available in Oxygen Forensic Suite including the Timeline and Links & Stats

Remote acquisition of Windows Phone devices is yet another technology licensed by Oxygen Forensics from its long-time partner, ElcomSoft Co. Ltd. Less than a month ago, Oxygen Forensics implemented full acquisition and analytic support for encrypted BlackBerry 10 backups produced with BlackBerry Link. The acquisition technology was also licensed from ElcomSoft as part of a long-standing relationship between the two companies. The partnership helps Oxygen Forensics secure technological leadership in the area of mobile forensics, acquiring information from more data sources than any single competitor.

About My Windows Phone (Windows Phone Live)

My Windows Phone (previously Windows Phone Live) is an online cloud service provided by Microsoft and enabling Windows Phone users to remotely locate their devices, manage applications, and backup and share pictures, documents, contacts and text messages across all registered Windows Phone devices. Valid account credentials (Windows Live ID and password) are required to make use of the service.

My Windows Phone provides Windows Phone users a free cloud backup with automated wireless synchronization for essential data stored in the device. Users can backup, manage and synchronize between multiple devices various information such as contacts, appointments, pictures, documents, text messages etc. via a password protected online portal. Access to My Windows Phone is available through Microsoft single sign-in service via Windows Live account.
