We are honored this year to have a schedule of pre-eminent leaders in the field of addiction to share their knowledge and experience with you. The conference will begin with an overview of the prescription drug epidemic and will feature **Douglas Gourlay, MD**, who will discuss misuse and abuse of prescription opiates. **Richard Ries, MD**, will provide an overview of addiction and co-occurring psychiatric disorders as well as a discussion of how DSM-5 impacts diagnostic issues. **Thomas Kosten, MD**, will present an overview of pharmacology as well as stimulants, including emerging treatments. As always, we will carry on a CSAM tradition of promoting collegiality and physician interaction with small group discussion of cases relevant to the topics presented to complement the didactic lectures. Additionally, we hope you will attend our grab-and-go lunch on Thursday, designed to facilitate organization of CSAM Connecting and Consulting Regional Groups so that you can carry the spirit of CSAM education and collegiality home with you. For our **Thursday night dessert reception** we have planned an evening in tribute to those who have inspired generations in addiction medicine. Friday night's **Roaring 20's themed dinner** will allow for further fun and interaction with peers in a relaxed setting.

Our **pre-conference workshops** will offer a more in-depth look at topics ranging from the complex patient, with case-based discussion of patients presenting with substance use disorders as well as pain and psychiatric issues; physician well-being; motivational interviewing; and the exciting emerging area of food and addiction.

Back by popular demand is our **ABAM Certification Exam Preparation Track** for those who would like more emphasis on test-taking tips, enriched study materials, practice questions, and guidance on how to make the most of valuable study time.

Whether you are preparing for the American Board of Addiction Medicine Certification Exam, refreshing your knowledge of the field, or deepening your understanding of the diagnosis and treatment of addictions, you are in for an educationally rich and rewarding experience.

## Who Should Attend?

Practicing physicians in both primary care and other specialty fields seeking an introduction to the full spectrum of substance use disorders, their diagnosis, and appropriate management.

Physicians preparing for the certification examination in addiction medicine requiring an overview of the core elements of addiction medicine in a way that allows them to identify the areas where they may need more study.

Physicians currently practicing in the field who want a refresher course based on the latest clinical research.

Other health care professionals, including psychologists, therapists, nurses and drug abuse counselors, who are involved in the treatment of patients with substance.



## Addiction Medicine Review Course

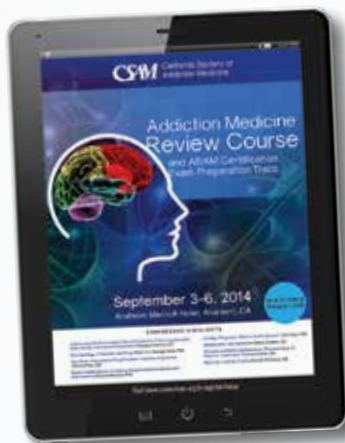
The three-day Review Course (Thursday through Saturday) presents an overview of the core elements of addiction medicine, presented by top experts in the field. It can serve as a broad review for clinicians, a review of the basics for newcomers, or a starting point for self-assessment and study for those planning to sit for the American Board of Addiction Medicine Certification Exam. Since it is not designed exclusively for test preparation, some material not likely to be on the test will be included in plenary sessions as part of providing the foundation for informed clinical practice. Participants sit at tables with a facilitator who will guide case discussions and answer questions. Participants receive a course syllabus on a USB drive with copies of all lecture handouts and selected articles and have the opportunity to purchase a print syllabus.

## American Board of Addiction Medicine Certification Exam Preparation Track (additional fee)

In addition to the three-day Review Course, CSAM also offers an ABAM Certification Exam Preparation Track. Prior to the Review Course, Exam Track participants will download a study guide organized by topic. Also, those taking the Exam Preparation Track will be able to access an online pre-conference assessment test to help identify areas where additional study may be needed. The Certification Exam Preparation Track at the conference consists of a four-hour workshop on Wednesday afternoon (September 3) and three one-hour sessions on Thursday, Friday, and Saturday mornings, prior to the start of the Review Course. Content includes test-taking strategies, sample questions, high-yield exam content, and tips on how to prepare for the exam. A post-conference practice exam will also be available. Those taking the Certification Exam Preparation Track must also sign-up for the Review Course.

### The Complex Patient: Pain and Prescription Opioid Abuse

Prescription opioid abuse has become an epidemic in this country. This advanced workshop reviews the complex biopsychosocial factors that contribute to this problem, and provides specific strategies for how individual providers and larger health care systems can work with these patients to mitigate the problem. This workshop also provides advanced training on the use of buprenorphine during the perioperative period, and how and when to taper buprenorphine.

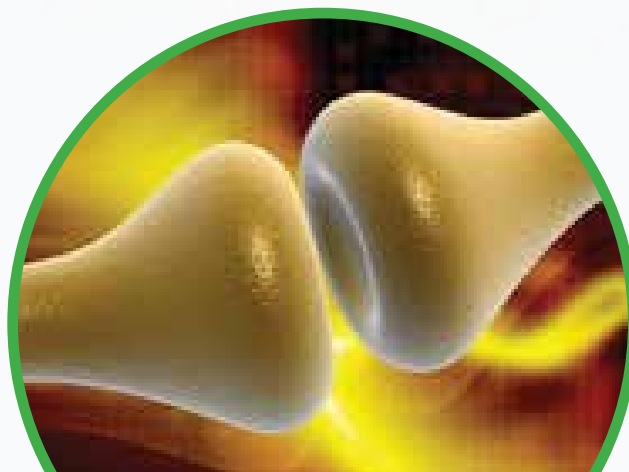

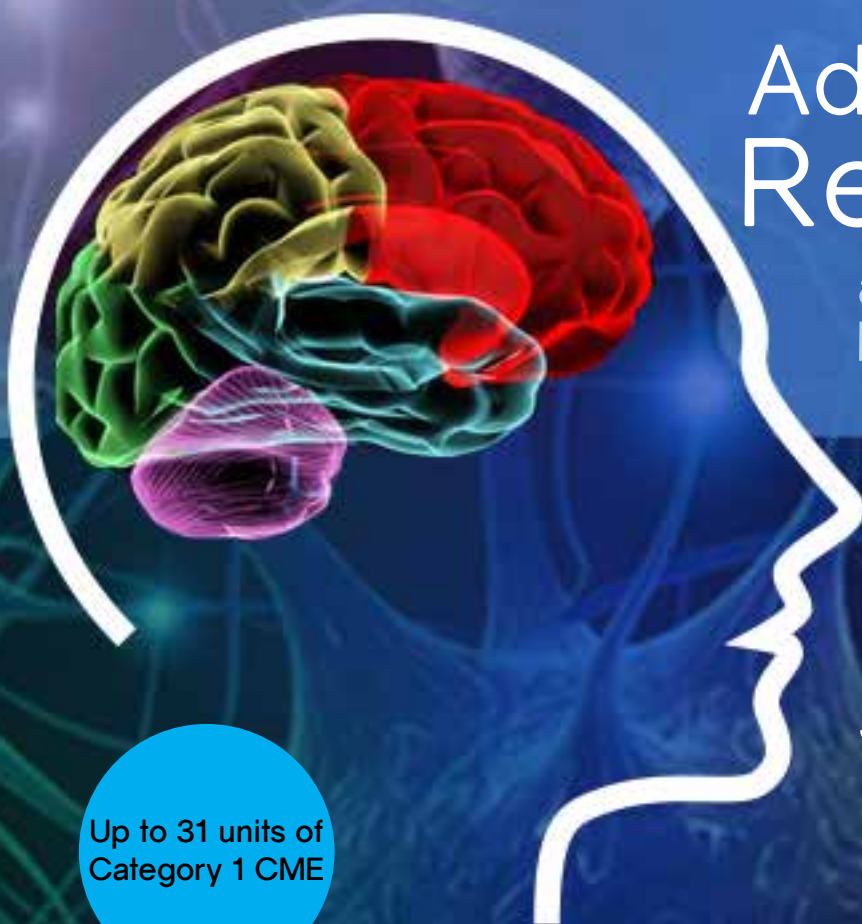
