Search Engine Optimization

- The effort to improve the visibility of a website within the search engine’s natural “un-paid” results for specific keywords.
- Different Kinds of Search:
 - Image
 - Local
 - Video
 - Academic
 - News

Search Engine Optimization

- Search engines use crawlers to find pages within a website.
- Crawlers don't crawl an entire site at once. Instead they come back according to the frequency of content.
 - A website that produces articles everyday will be crawled more often than websites that produce articles weekly/monthly.
- These pages are then analyzed using the search engines algorithm. Google's algorithm is different than Bings.

Getting Indexed

- Once you understand what your target market is looking for you can more effectively reach those users.
- The 3 Types of Searches:
 - “Do” Transactional Queries - Buy a Plane Ticket
 - “Know” Informational Queries - Name of that Band?
 - “Go” Navigational Queries - Homepage of MLS

Types of Searches

- Crawling & Indexing Problems
 - Robots.txt & .htaccess files
 - Poor Link Structure - Sitemap.xml
- Interpreting Non-Text Content
 - Forms, Images, Video, Flash, Audio
- Calling a Thing by it's right name
 - Tenant vs. Boarder or Lodger (Know your audience)
- Outstanding in the Field
 - If the content isn't seen or linked to it may be deemed unimportant.

Keywords

Usage, Targeting, Domination, and Abuse

- One of the best ways to “optimize” a page’s rankings is to ensure that keywords are prominently used in titles, text, and meta data.
- Keywords are the building blocks of language. But you must understand user intent.
 - Jack and Jill ran up the hill.
 - Is this article about running? Jack and Jill’s relationship? or the hill?

Titles, Text & Meta Data

- Search engines measure the ways keywords are used in order to help determine the “relevance” of specific content to a search query.
 - Query: Hill Running
- Keyword Stuffing is the act of inserting the keyword into the content abundantly.
 - The search engines ability to spot keyword stuffing has gotten incredibly good.
 - Example: An article on Hill Running that includes the keyword Sasquatch over and over again will be seen as stuffing.



Domination & Abuse

- Use Keyword
 - Title Tag
 - Alt Attribute of Image
 - URL
 - Meta Description
- Personal Rule: 1 Keyword Mention per 100 Words

- Put the text of the article into the field.
- Find the most frequently used words within content.
 - Exclude small words
 - Group variations
 - Determine list size

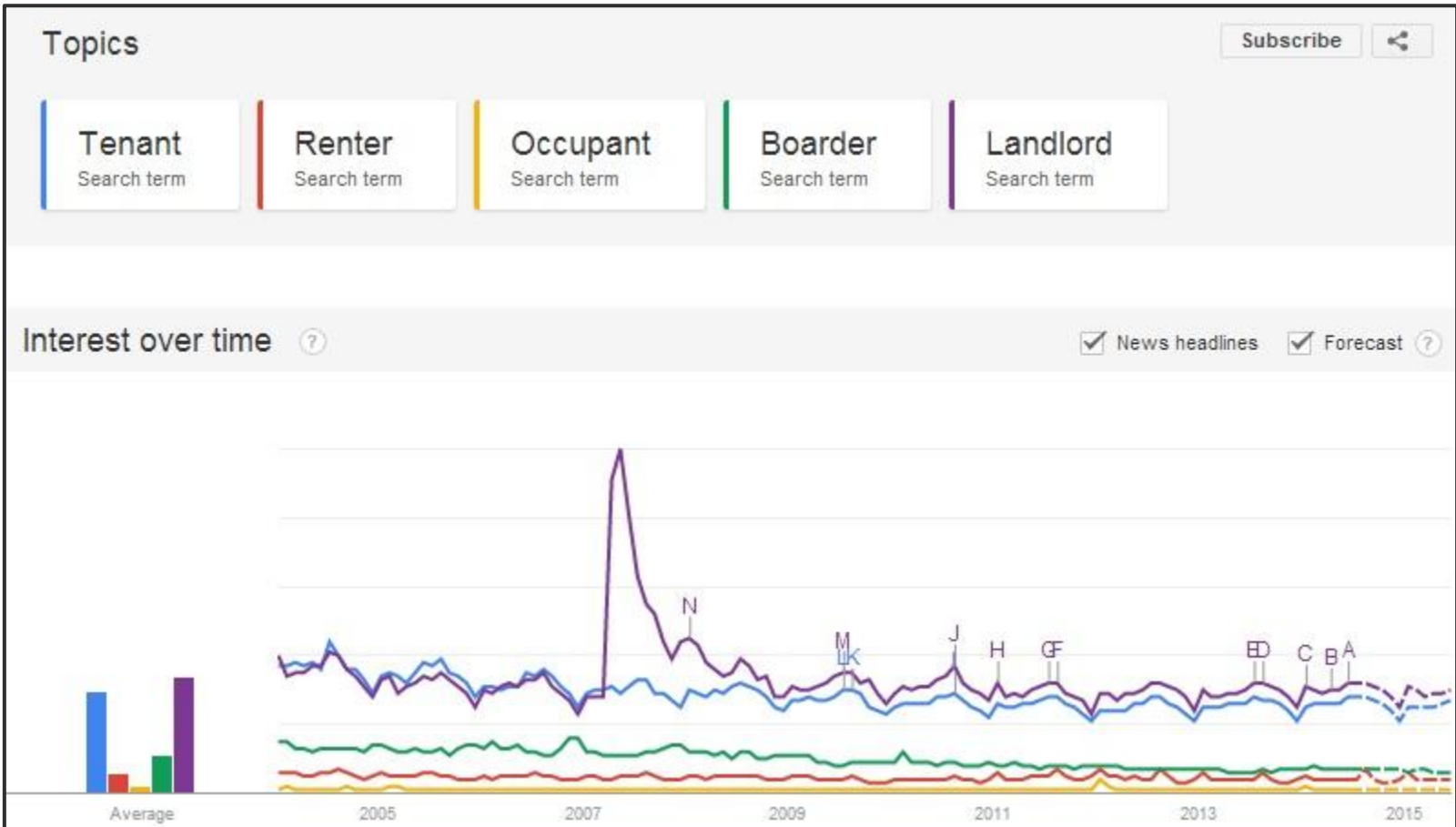

Google Trends

Title Tags

- Only display the first 65 - 75 characters.
- Keywords toward the front.
- Include Brand Name
 - Tenant Law: How to Win a Chronic Nonpayment Case | Adam Leitman Bailey (69 Characters)
- Compelling, Descriptive, and Readable.

Best Practices

Description

- Take sentence from article that includes keyword.
- Answer the question (Who, What, Why, When, How)
- Don't repeat the same description over and over.
- Don't include site name.
- Don't over punctuate. Ignore comma, semi-colon, etc.
- Don't exceed 160 characters.
- Don't use non-alphanumeric characters (ex. quotes)

Building Descriptions

- When done properly, this will allow the owner to either evict the delinquent tenants or force the tenant to become a regular payer.
- A system for all of its property owning clients, to identify intentionally late paying tenants and build chronic nonpayment cases.
- We begin by searching court records for previous cases and gathering prior orders and stipulations to evaluate the tenant's default history.
- We deliver rent demands to the tenant after the due date has passed. Starting the cases as soon as the tenant is in default strengthens our legal case.
- Owners must repair tenant apartments as much as possible to avoid any claims or defenses that the failure to pay the rent is based on a lack of services.
- We have our clients send letters to the tenants requesting an inspection to evaluate whether any repairs are necessary within their apartments.

Errors & Violations

- Googlebot - The Google Spider
 - Why Crawl Your Site?
 - How Often?
 - How Many Pages?
- Communicate with Googlebot
 - Sitemap
 - Webmaster Tools

Crawling

- Google Checks:
 - DNS & Server Connectivity
 - Site time out?
 - Pages couldn't be reached?
 - Robots.txt Fetch
 - Errors in the Robots file?

Crawl Errors

- Different Kinds
 - Page Sitemaps
 - Video Sitemaps
 - Mobile Sitemaps
 - Geo Sitemaps - Now included in Regular Sitemaps.
 - News Sitemaps - Must be accepted into Google News.
- Suggestion:
 - Split Out Sitemaps over 100 links

XML Sitemap

- Control where engines are allowed to crawl
 - Block
 - In-Site Search Results
 - Canonical Folders: Archive
 - CMS Specific Folders: wp-admin
 - Comments (Optional)
 - Other Ways to Block Content
 - noindex
 - nofollow
 - .htaccess - Password Protected Folders
 - Remove Content Request in Webmaster Tools
 - Be Careful!!
