SPEAKER AGREEMENT

This agreement is between Presenter or Presenters herein referred to as "Presenter," and Green Planet Festivals representing the event executive producers.

RELATIONSHIP OF PARTIES

The parties intend that the relationship between them created under this Agreement is that of an independent contractor only. Presenter is not an agent or employee of Green Planet Festivals.

CANCELLATION OF PRESENTATION

Green Planet Festivals reserves the right to cancel an event due to acts of God, or as reasonably necessary in the ordinary course of business. Green Planet Festivals shall notify the Presenter, by telephone or e-mail, within forty-eight (48) hours of the cancellation of the event. Presenter agrees to present on specified date and time.





TERMINATION FOR CAUSE

Either party hereto, may terminate this Agreement upon (a) thirty (30) days written notice to the other, or following any material breach or omission by the other with respect to any term, representation, warranty, condition, or covenant hereof, and (b) the failure of such other party to cure such breach or omission prior to the expiration of such 30-day period.

OBLIGATION OF CONFIDENTIALITY, PRESENTATION CONTENT, MEDIA USAGE

Presenter:

- Agrees that they shall not directly or indirectly disclose, disseminate, publish articles concerning, or otherwise make known or available to any person or entity not confidentially bound to Green Planet Festivals any Confidential Information of Green Planet Festivals without prior written permission from Green Planet Festivals.
- Agrees to the best of their knowledge, that their presentation content: text; references; photos; videos do not violate any proprietary or personal rights of others (including, without limitation, any copyrights or privacy rights); and that the presentation is the original work of the presenter with accurate facts, void of any content that may result in libel or unlawful actions.
- Grants to Green Planet Festivals permission to use, reuse, broadcast, display, reproduce, distribute and reprint, in any form and through any media, a photograph, videotape, film, digital medium, illustration or art work, the name, voice and biographical information of the Authorized Presenter that is used in the production of Green Planet Festivals. This grant shall be for purposes of advertising or marketing Green Planet Festivals events. I authorize Green Planet Festivals to use my name, biography, photograph/s, for the purposes of promotions for Green Planet Festivals.

SEVERABILITY

If one or more of the provisions contained in this Agreement shall for any reason be held to be unenforceable or excessively broad as to time, duration, scope, activity or subject, such provisions will be construed, by limiting or reducing it, so as to be enforceable to the extent compatible with the then applicable law. If any provision of this Agreement, or the application of such provision to any person or circumstance, shall be held invalid, the remainder of this Agreement, or the application of such provision to persons or circumstances other than those as to which it is held invalid, shall not be affected thereby.

WAIVER

Waiver by any party of one or more terms, conditions or defaults, of this Agreement, shall not constitute a waiver of the remaining terms and conditions of any future defaults of this Agreement.

NOTICES

All notices and other communications required or permitted under this Agreement shall be validly given, made, or served if in writing and delivered personally or sent by registered mail, to the other party.
