#### **Risk Management**

ATOM includes an integrated risk management subsystem that provides real-time risk management for treasury activities. Risk functionality includes:

- Instant exposure reporting for any counterparty across assets, liabilities, and derivatives
- Aggregate exposure reporting by category, including asset class, credit, industry, currency, country, term, and rate term
- Mark-to-market, mark-to-model, shocking, CVA, and sensitivities for all debt, investment, and derivative types
- Powerful, user definable limit management with limit alerts for single and cross products
- Market data integration with Bloomberg, Reuters, and other market data providers

#### **Finance and Accounting**

ATOM provides automated accounting for all cash, derivative and capital markets activities. ATOM also delivers full hedge accounting functionality, including support for ASC 815, IAS 39, and IFRS 9. Robust sub-ledger functionality supports daily feeds to one or more General Ledger or ERP systems, including SAP, PeopleSoft, Oracle, and JD Edwards.

#### **Governance and Compliance**

Real-time policy compliance and workflow capabilities in ATOM offer organizations the corporate governance tools they need to establish, maintain and monitor compliance within multiple regulatory frameworks including Sarbanes-Oxley, Basel, Dodd-Frank, and IFRS/GAAP.

- Real-time integration with Excel for all ATOM data


