All archived emails are accessible in an online view and are exportable as PDF, message download or PST download for easy end user access.

All data is secured via industry standard encryption with a unique key assigned to each archive. There is never co-mingling of archive data. At the application layer we use Secure Socket Layers (SSL) to encrypt all communications between the browser and the datacenter. A processing pipeline ensures the performance and privacy of each archive.
