"Originally we sought to work with OnRamp to utilize their facility strictly as a colocation site," said Aquiles Mata, Security Officer at DaVincian Healthcare. "But as OnRamp started to expand the breadth and depth of their service offerings, we began looking into the ways we could leverage their additional IT services to improve the security and reliability for the data we possess and the deliverability of our software solutions.
