The CRC evaluates and makes recommendations to the Board of Directors regarding alleged violation of NAID’s code of ethics. Complaints may come from members, non-members and consumers. These ethical complaints range from trademark infringement to improperly disposing of information. Members of this committee meet monthly to hear the cases, discuss the complaints, and recommend appropriate action.
