For healthcare businesses this puts a far greater emphasis on encryption, because if not utilized properly, their data and HIPAA compliance could be at risk.” Martin went on to add, “While HIPAA defines the guidelines and the necessity for encryption, businesses are now seeing the need to go beyond these basic requirements to secure their data in new ways, in an effort to combat new threats.”
