# In-house design competition to support neighborhood revitalization efforts in Greater Pittsburgh area

Pittsburgh, PA (July 6, 2015) The Pittsburgh office of top international design and architecture firm Perkins Eastman is pleased to announce the winning concepts of the firm's in-house design competition to create a new prototype for sustainable future housing for Habitat for Humanity of Greater Pittsburgh (HFHGP). The design competition was open to the firm's 900 employees across its 14 global offices and entries were judged by a jury of design and construction professionals and local Pittsburgh stakeholders.

Alan Schlossberg AIA, LEED AP, an Executive Director of Perkins Eastman and Managing Principal of the firm's Pittsburgh office, says: "Perkins Eastman is very excited to help vision a next generation of Habitat houses." He continues, "Through our in-house design competition program, we are able to use our firm's immense design talent to help struggling families in our region—to help HFHGP achieve their vision of 'a decent place to live' for everyone in our community."

In anticipation of its 30<sup>th</sup> anniversary next year, HFHGP sought an improved prototypical house that would showcase sustainable solutions for common problems such as water/energy efficiency, conservation of materials, and carbon footprint and that would provide innovative, functional spaces for a family of five. It looked to Perkins Eastman for outside-the-box ideas and sustainable design expertise.

"We are grateful to Perkins Eastman for hosting this design competition, and to the community members and other organizations who are represented on our sustainable construction committee. We cannot thank them enough for working so hard to make this green building project possible," says Habitat for Humanity of Greater Pittsburgh's Executive Director, Maggie Withrow. "Once constructed, this decent, affordable home will go to a qualified Habitat program family."

The house will be constructed on an empty lot owned by HFHGP in the City of McKeesport, a town located at the confluence of the Monongahela and Youghiogheny rivers and part of the Pittsburgh metropolitan area. HFHGP is among many organizations working to revitalize McKeesport, a once-thriving steel manufacturing town. The design competition intends to spur these revitalization efforts.
