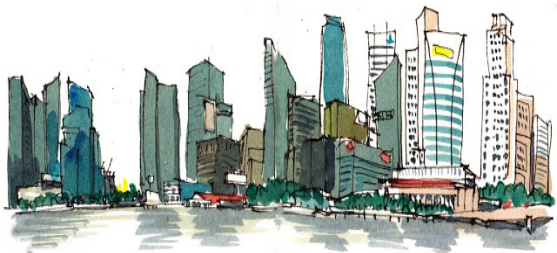

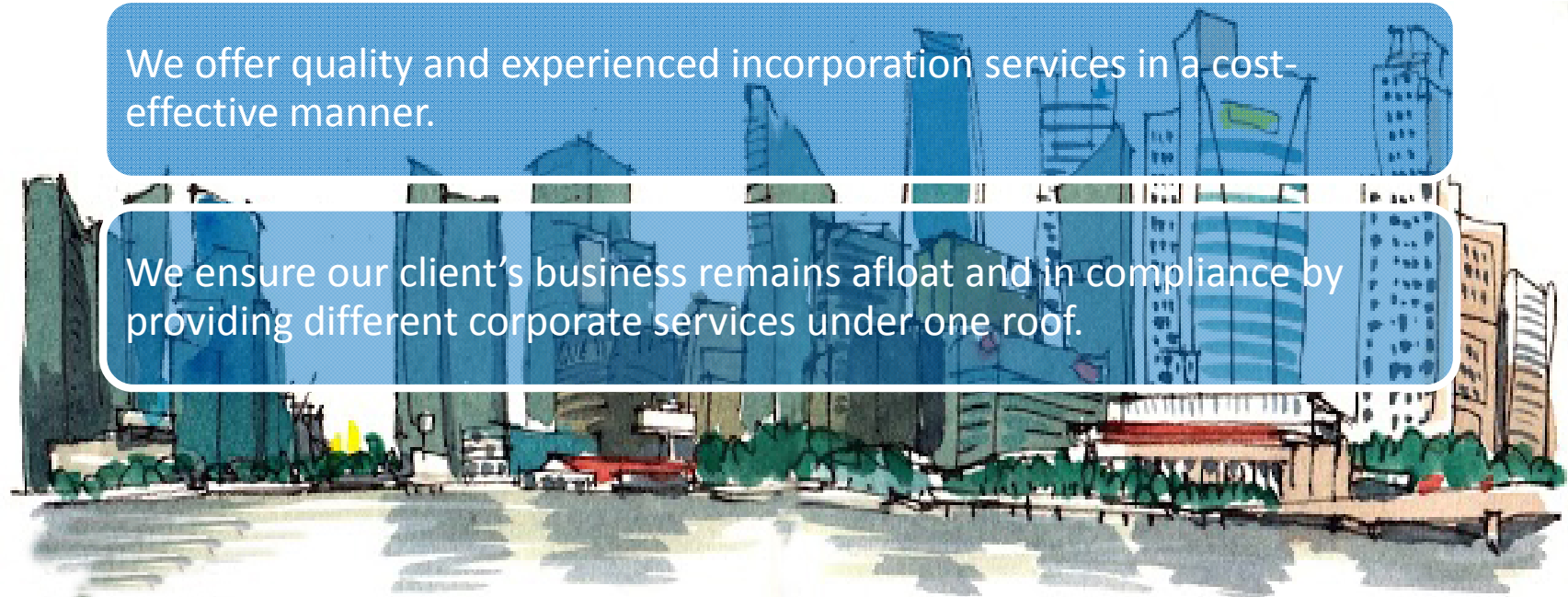

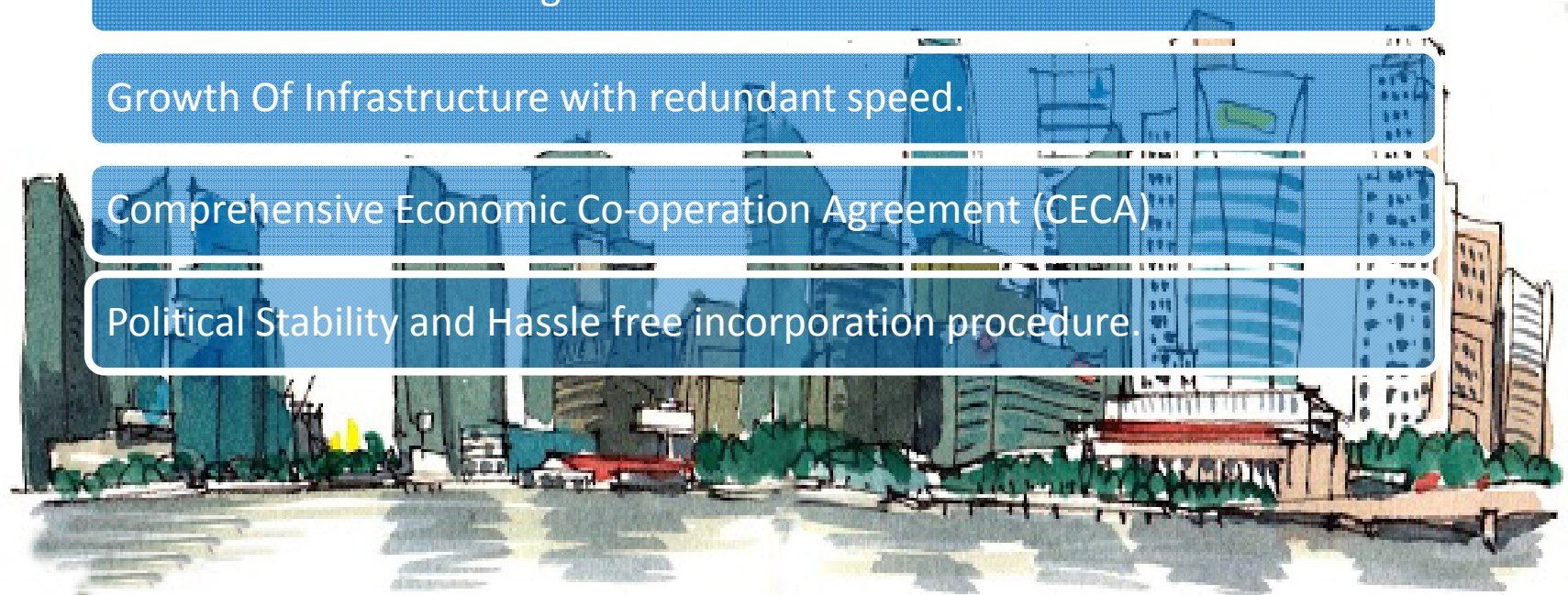

# VARIOUS BUSINESS ENTITIES FOR INCORPORATION IN SINGAPORE

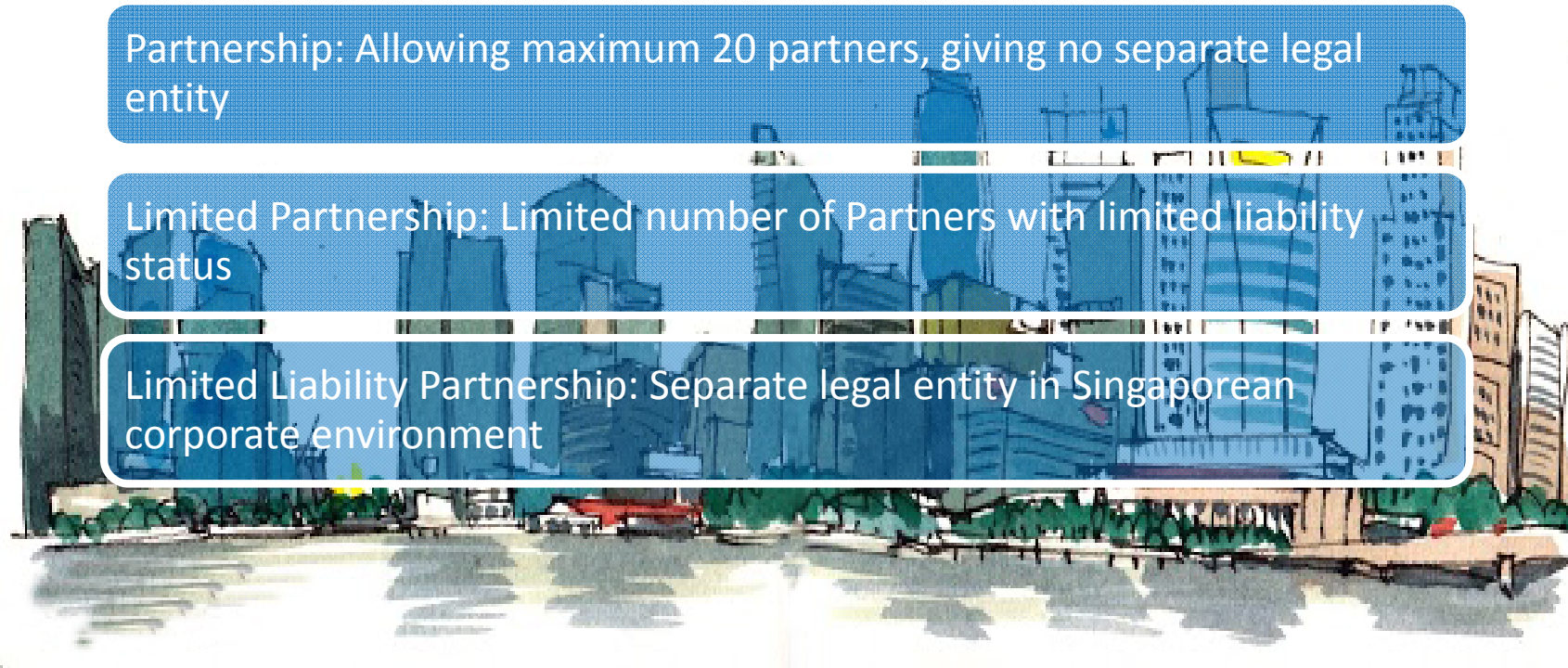
Sole Proprietorship: No legal status of individuals and businesses

Companies: Having separate legal distinction with limited liability for the shareholders

Partnership: Allowing maximum 20 partners, giving no separate legal entity

Limited Partnership: Limited number of Partners with limited liability status

Limited Liability Partnership: Separate legal entity in Singaporean corporate environment





# OPTIONS FOR FOREIGN COMPANIES TO INCORPORATE IN SINGAPORE

## **Foreign Subsidiary :**

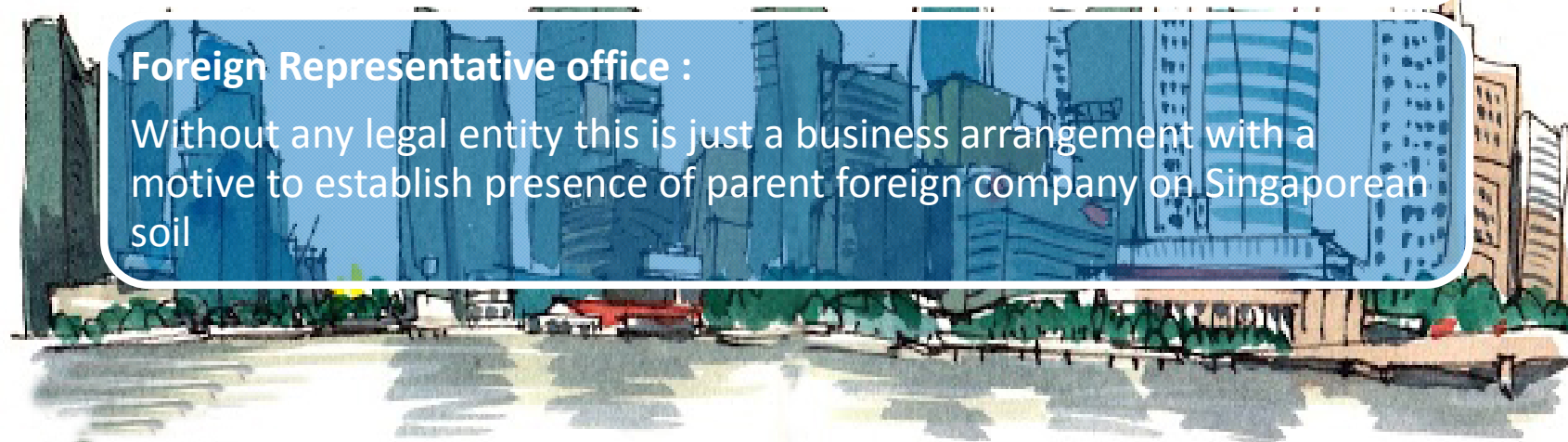
If the major shareholder of the private limited company is a foreign company.

## **Foreign Branch :**

Not a separate entity and not part of the foreign company

## **Foreign Representative office :**

Without any legal entity this is just a business arrangement with a motive to establish presence of parent foreign company on Singaporean soil

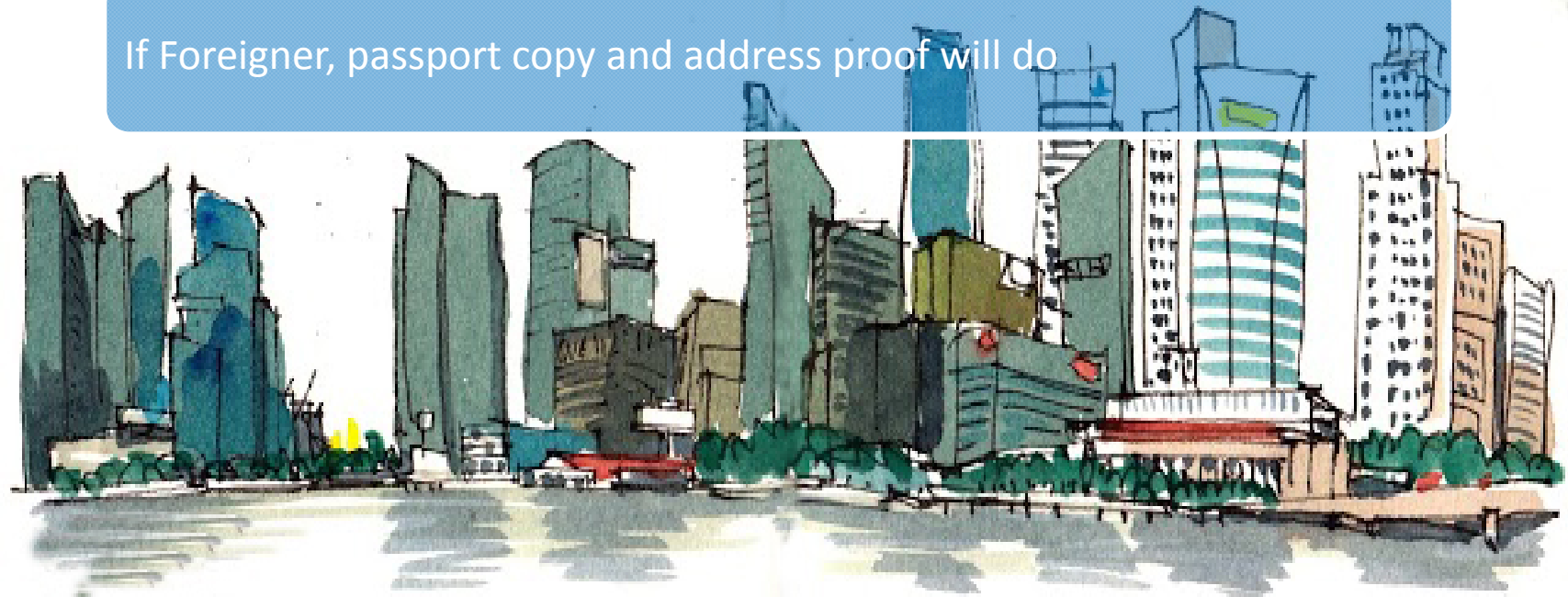


# DOCUMENTS REQUIRED TO INCORPORATE A BUSINESS IN SINGAPORE

If Singapore Residents, Singapore ID Card copy for Citizens and Copy of Passport for others

If Non-resident, a copy of passport along with the copy of valid residential address proof

If Foreigner, passport copy and address proof will do

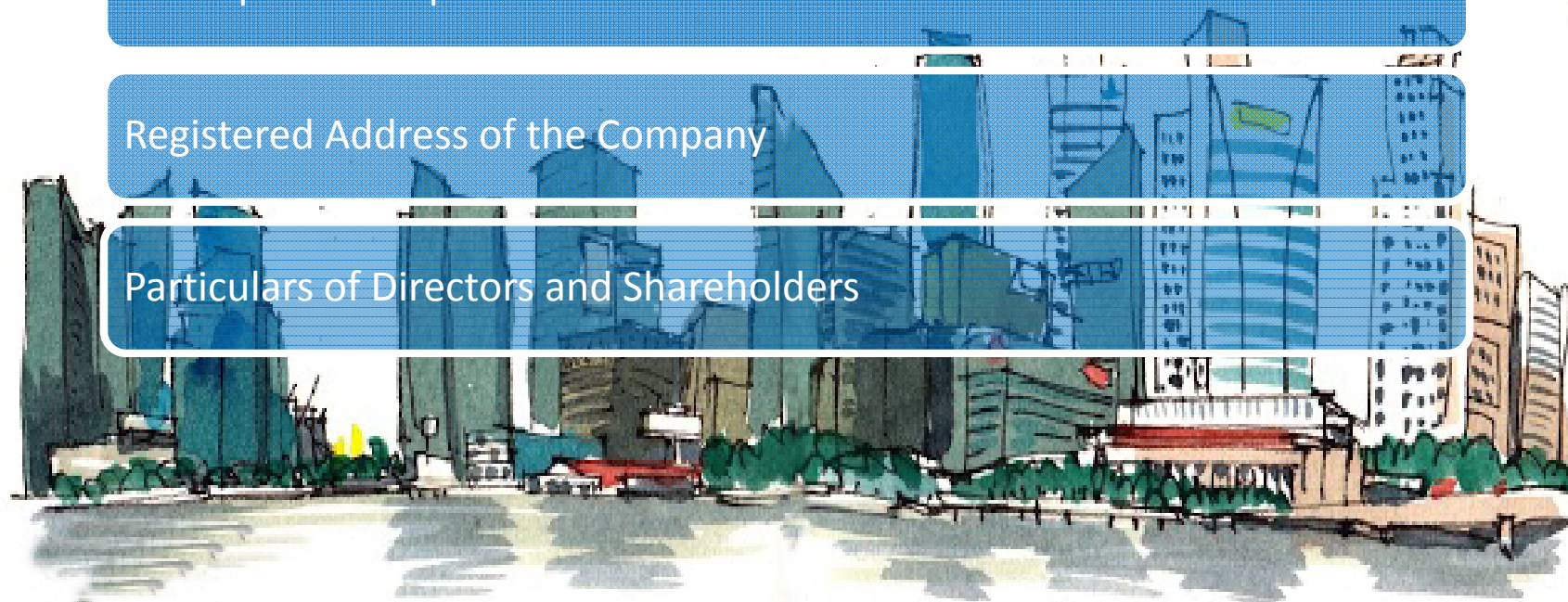

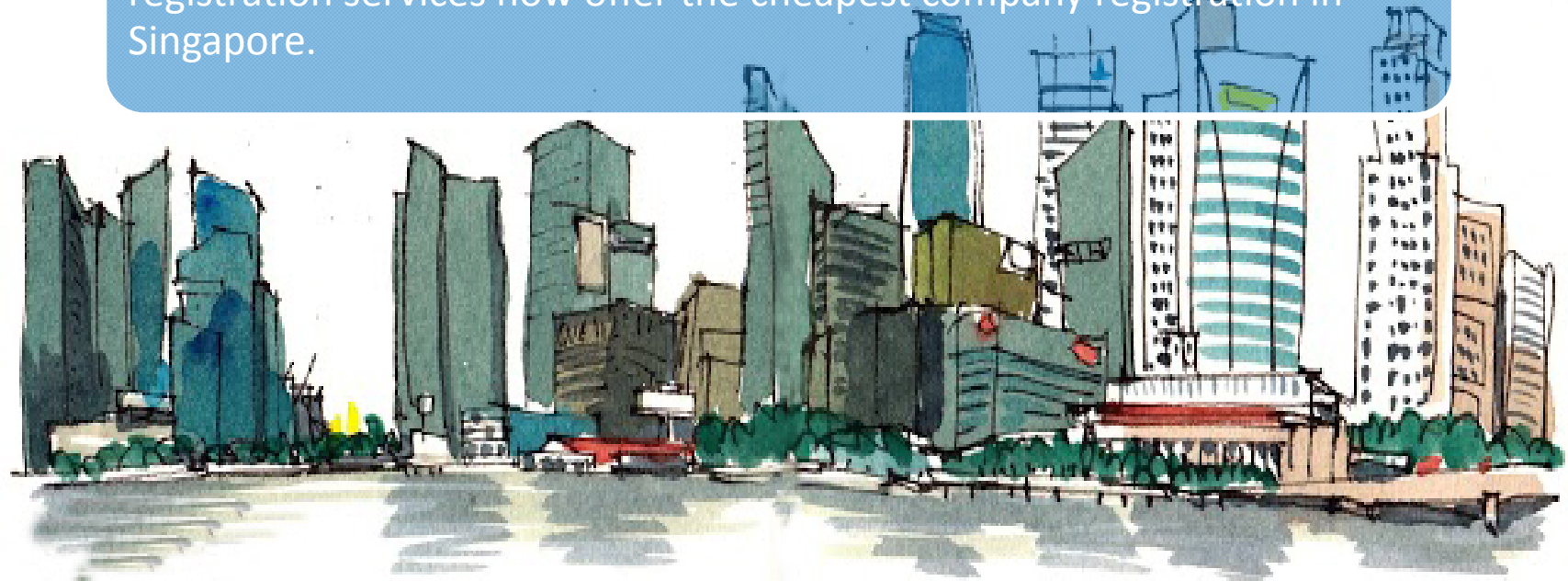
