Additionally, ClickDimensions ranked 25th (of 336) within the software industry segment and is the 2nd highest-ranked software company in the state of Georgia. The Inc. 5000 list is billed as “the fastest-growing private companies in America” and requires the signature of a certified public accountant for verification of revenue numbers. To be considered for the 2015 list, companies must have generated revenue by March 31, 2012, generated at least \$100,000 in revenue in 2012, and generated at least \$2 million in revenue in 2015.
