Due Diligence - Commercial Property & Casualty

- Conduct cost of risk analyses, which includes identifying current cost of risk (premium plus projected losses) and comparing to post-close projections
- Compare premiums, projected losses and loss accruals to the income statement and balance sheet for potential impact on earnings
- Conduct analyses of loss reserve and payout pattern to assess collateral and balance sheet requirements and post-close cash management
- Provide post-closing insurance budget for pro forma financials and post-close insurance budgets
- Review Surety Bonds and their impact on the balance sheet, working capital levels and indemnity obligations
- Audit premium liabilities
- Review coverage to identify gaps or inadequacies and verify carrier solvency
- Analyze the Purchase Agreement from an insurance and employee benefits perspective
- Review lender requirements and provide insurance documentation for closing
- Determine the adequacy of loss prevention and safety programs in place

Due Diligence - Employee Benefits

- Confirm healthcare costs on a fully Insured and/or self-insured basis
- Estimate pre-close accrual liabilities on self-funded plans
- Develop plan and cost benchmarking
- Determine potential Affordable Care Act (ACA)/Obamacare impact on healthcare costs
- Conduct cost projections and pro formas
- Review adequacy of current plan design, cost containment and cost-sharing options
- Confirm ERISA Compliance - COBRA, 5500 filings, others
- Determine accrual liability on run-off plans, COBRA liabilities, retiree coverage and rollover deductibles

- Place Key Man insurance
- Review retirement compliance plan and cost projections
