To be considered:

A business must be accredited with the BBB® for a minimum of three years and maintain a B rating. A charity must be accredited with the BBB®.

The 2016 Torch Awards judging committee will select one business or charity from each of Better Business Bureau<sup>®</sup> of Fort Worth and Tarrant County, Inc.'s. eight service-area counties who demonstrate success in the criteria categories to be recognized as an award winner. Each winner will be honored with a ceremony at their office or community building and will receive recognition from the local media.

Award Criteria Categories

Exceptional Ethics Community Involvement Customer Service

From these eight selected recipients, the committee will select a top winner for each criteria category who will be honored at the Awards Gala, scheduled for February 20, 2016 at the Fort Worth Zoo.

All Torch Award recipients will receive recognition at the Annual Awards Gala. If you are a county award recipient, you are required to attend the gala, or send a representative on your behalf to accept an additional award.
