

Set in the leafy Cape Town suburb of Lake Side, with its back enclosed in the walls of the Silvermine Mountains, Westlake Golf Course has gained an illustrious reputation as one of the Cape's premiere courses. Golf at ERINVALE, hosts to 1996 World Cup of Golf, with sharp contrast between former and latter nine. The Erinvale golf course, designed by the legendary Gary Player, is conveniently located on the borders of Somerset West and only half an hour from the vibrant Cape Town. Having hosted the 1996 World Cup of Golf and the second oldest tournament in the world, the prestigious SAA Open in 2003 and 2004, Erinvale is no stranger to worldwide media coverage. The course also boasts breathtaking views of the False Bay coastline from the top holes.

Play at STEENBERG, Cape Town.

Golf at STEENBERG, a Peter Matkovich hybrid, with the longest green in Africa on hole 14. Rated among the top 3 golf courses to visit in South Africa, Steenberg, nestled in the crook of the Constantiaberg Mountains, lives up to its fame with a charming location. Designed by the eminent golf course architect Peter Matkovich, Steenberg follows his principle that good golf course architects "listen to the land". Recently voted "Top foreign golf resort" by Conde Nast Traveller readers, Steenberg is one of the most prestigious golf courses in South Africa.

Clovelly



Play at CLOVELLY, Cape Town.

An internationally popular seaside parklands with computer-irrigated fairways, nestled in the tranquil Silvermine Valley between Fish Hoek and Kalk Bay, the Clovelly Country Club rewards accuracy off the tee and provides players with scenic views of the False Bay coastline. Known for its year round conditioning, the relatively short course possesses a unique character by virtue of its proximity to the sea. Dune lined fairways lead to excellent bent grass and poa annua greens; while the many trees on the course add to the challenge and also create shelter from the strong summer sea breeze.

TERMS AND CONDITION

Please read the following booking conditions carefully, as they set out the terms and conditions of the contract between you and Tour Operator. We act as booking Tour Operators for the suppliers of the component parts of the holiday we organise, and as such, bookings for their services will form a direct contract between you and the relevant supplier, and will be subject to that supplier's standard terms and conditions.

Bookings

Contact the Tour Operator by email, fax or phone. All enquiries for quotations and bookings will be replied to in writing. Confirmations, amendments and cancellations of bookings must be received by the Tour Operator in writing. Please supply as much information as possible when making an enquiry. Special requests must be in writing and Tour Operator will make every attempt to meet those requests. All reservations are subject to our cancellation policy.

To confirm a booking we require a 20% non-refundable deposit. Please note that some third parties require full or partial advance payment in order to secure and confirm space. Tour Operator may therefore require a larger deposit to process the booking. All travellers must take out comprehensive travel insurance.

Quotations are valid for the dates specified and are subject to adjustment if the services quoted for are not available at the time of booking. Changes to the quotation, requested by the traveller / Tour Operator, that incur additional costs will be charged to the traveller / Tour Operator. Prices are also subject to adjustment in the event of changes in government imposed taxes, fuel prices, air fares, hotel charges, tourism levies and/or the introduction of national, regional or local taxes or levies of whatever nature. Prices for the services of subcontractors/third parties may vary, however such changes will be communicated in writing to the traveller / Tour Operator. Acceptance of the quotation will be regarded as acceptance of Tour Operator's Terms and Conditions of business.

Late Booking Fee & Communication Expenses (Telephone Calls)

In the event of a booking (except South Africa bookings) being made less than 7 days prior to the date of departure, Tour Operator reserves the right to charge for any extra communication expenses. Full payment is due immediately on confirmation and is non-refundable on all late bookings. Some bookings require full payment at the time of booking i.e. prior to confirmation. If we are unable to secure confirmation you will be refunded in full.

Price Changes

- The costs associated with travel arrangements are not always stable, and currency movements can fluctuate sharply. It is impossible to predict these movements in advance. When you book a package through us, we reserve the right to pass on any surcharges to you. Surcharges may be imposed to cover increases in transportation costs, including the costs of fuel and security charges, taxes or fees chargeable for services such as landing taxes or embarkation or disembarkation fees at ports and airports, or exchange rates applied to the particular package.
- b) The Tour Operator guarantees the price of land arrangements; only once full payment is received.
- c) Airfares are subject to the prices and conditions quoted by the particular airlines and cannot be guaranteed by the Tour Operator. The onus is on the Tour Operator & the passenger to check that there have been no changes in these prices before making final payment thereof.
- d) Should the client make a group reservation & subsequently the group numbers deviate from the minimum number required for the booking, the Tour Operator reserves the right to re-cost the price and raise a surcharge. Should any client refuse to accept and pay such surcharge, it may result in cancellation of the booking and forfeiture of all payments made.

Documents

- a) Documents (vouchers, itineraries, etc.) are only prepared on receipt of full payment of the package price, and signed & completed Booking Form, and will be ready 24 hours after payment has been received.
- b) Should you require your documents and air tickets to be forwarded to either yourself or the departure airport this may be arranged by your Tour Operator with us. However, the courier costs in respect thereof will be for your own account.
- c) It is important that you check all details of your travel documents (including your itinerary) before arriving in South Africa. If there are any inaccuracies on any of your travel documents, or should you have any further queries, you should contact your travel Tour Operator immediately. The Tour Operator will not be liable for any delay and/or loss occasioned as a result of any inaccuracies on any travel documents once you are in receipt thereof and you have arrived in South Africa.
