RE: Polygraph Examination of Yuriy Seretskiy Conducted on September 24, 2015

Pursuant to a request, I conducted a Psychophysiological Detection of Deception Test (a polygraph examination) with examinee Yuriy Seretskiy in regards his truthfulness in the questions listed below. The examinee was positively identified via a valid CDL The exam was conducted at California.

During the pre-test interview, the examinee discussed the relevant issues (listed below as the questions). The examinee appeared to be in normal health and not under the influence of any manipulative substance. As a certified DRE, I (Investigator Elkins) routinely observed the examinee ability to follow instruction as well as pupil reaction and lateral and vertical gaze nystagmus. All reactions were normal. After an initial interview the examinee was asked if he thought he was being treated fairly and he replied "yes".

Comparison questions were also included in this examination, using a technique approved by three national polygraph organizations and the U.S. Government's Polygraph Institute. A Limestone computerized polygraph instrument was used to record the subject's cardio/pulse responses, upper and lower respiration, and electrodermal skin conductance tracings. A counter measure pad was also used to prevent/measure any attempts at counter measures. The instrument was functionality-checked per factory procedure for the day of this examination; all functions were satisfactory. This is the same instrument and the same techniques that are approved by and used by the F.B.I. the C.I.A. and the D.O.D.

Three (3) examination charts were taken, following one (1) acquaintance test that was administered in order to observe a 'known lie' pattern. All factory functions were normal.

## The examinee was asked the following relevant questions:


- 1) Do you represent or plan to represent any Businesses? (Examinee's answer: NO)
- 2) Do you represent or plan to represent any special interest groups? (Examinee's answer: NO)
- 3) Are you backed by any organization? (Examinee's answer: NO)
- 4) Would you give your life to effect positive change in this country? (Examinee's answer: YES)
- 5) Would you betray your voters for any amount of money? (Examinee's answer: NO)
- 6) Are you 100% honest with your voters with everything? (Examinee's answer: YES)
