On a recent project, Johanna and her team helped a client extract the most relevant files from within more than two terabytes of data on their network by utilizing Pinpoint Labs Harvester. They utilized key features such as keyword searching, date ranges, limiting results by file type, deNesting and deduping while maintaining a chain of custody, hash values, and timestamps. The keyword search criteria on this particular project included 35 phrases, 1 proximity search and several wildcard searches.

“One feature that made the project time- efficient and cost- effective was the ability to stop and resume jobs at any point. Due to time constraints, it was necessary to stop the process- part way-

through enumeration and collect relevant documents from the file list so the review team could start looking at responsive documents.” She continued, “Being able to see how many documents Harvester was finding while it was still searching proved to be helpful, because it showed the client how much they were saving in collection and review.”

All in all, the project took just over two weeks to complete. Rather than the client having to pay someone to review the initial two terabytes of data, Harvester narrowed that down to about 25 gigabytes of relevant files. Johanna says, “Even though this type of project is fairly complicated, Harvester has an interface that is clean and easy to navigate. And support at Pinpoint Labs is second to none.
