Exhibitor Prospectus

1. One exhibit space: \$2,000 USD.
Two spaces: \$3,500 USD.

2. Assigning of booth space is on first-come-first-served basis. The applicants must pay the fee in full so that the application is EFFECTIVE. The application will be confirmed by email or fax.

3. Exhibit booth package will include the following:

- Booth size: 182cm (72") x 182cm (72")
- Table size: 182cm (72") x 76cm (30")
- Two chairs
- Standard electricity covers one booth, additional electricity may require additional fees.

OTHER ITEM SHALL BE PAID FOR BY THE EXHIBITOR

4. Exhibitors are not permitted to sublet or assign the whole or any part of space allocated to them apart from affiliated business or corporation, a subsidiary, or a parent company. The exhibitor is to be held liable for any activities carried out by persons occupying and using the space. Due to security reason, it is required to have an attendant at the booth during all open hours.

5. The event organizer has a right to reassign and rearrange the space in order to consolidate the exhibit space or for other reasons.

6. Exhibitor personnel will have access to the exhibit hall during the following hours:

MOVE-IN

Saturday, Nov. 12, 2016, from 9:00 am to 10:00 am

SHOW HOURS

Saturday, Nov. 12, from 10:00 am to 5:00 pm

Sunday, Nov. 13, from 9:00 am to 4:00 pm

MOVE-OUT

Sunday, Nov. 13, from 4:00 pm to 4:50 pm

The timetable is tentative at the moment and can be subject to change. The exhibitors will be informed about the final schedule through email before the show.

7. The event organizer reserves the right to refuse any display considered inappropriate. Any equipment higher than 10 feet needs a permit to be exhibited. In addition, displays and backdrops more than 4 feet high shall be exhibited at the back of the booth. It is not allowed to block neighboring booths. It is required that all exhibits remain within the defined space of their booth. If not, extra charges will be applied.

8. Distribution of catalogs, pamphlets, and samples is only allowed in the exhibitor's booth.

9. Smoking is NOT allowed in the exhibit hall.

10. It is forbidden to nail, tape, post or in any other way fix to doors, walls, or other places of Kowloon Shangri-La Hotel (Hong Kong) of signs or display materials that may result in property damage. Any damages caused by failure to observe this rule will be paid for by the exhibitor.

11. Exhibitors are required to obtain theft, fire and other kinds of insurance. All exhibit material shall comply with safety regulations, insurance underwriter, and local fire laws. It is forbidden to have any flammable and explosive substances and materials. When the exhibit is set up, it is required to remove containers and packing materials from the exhibition space. All necessary electrical work shall follow local regulations. The exhibitor is responsible for assuring the compliance with regulations on health, safety, and fire, both municipal and provincial.

12. The event organizer does not provide insurance of exhibitor's equipment from theft, loss, breakage, or damage. Neither representatives of the event organizer and sponsoring organizations, nor representatives and employees of the Shangri-La Hotel can be held liable for any loss, damage, or injury to property or employees of the exhibitor. The responsibility for any damages or injuries caused directly or indirectly by the actions of the exhibitor lies on the exhibitor.

13. If the exhibit display or booth equipment does not arrive, the exhibitor will still be held responsible for rentals and no refund will be given.

14. Any matters that are not specified in this prospectus shall be subject solely to a decision of the event organizing committee.

15. If the exhibitor decides to cancel the exhibition, a 50% refund will be issued prior to September 15, 2016. After that, there will be no refund.
