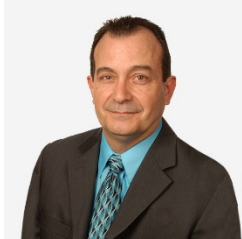


Tony DeGregorio joins ThoughtFocus as Chief Technology Officer (CTO)
