Accordingly, you are in violation of the Protective Order, which limits the disclosure of these documents. Please confirm at once that you have come into compliance with the Protective Order by removing the above documents from your firm's website, and provide a copy of your server logs reflecting any access to or downloads of the aforementioned documents.

Additionally, those documents on your website (to which readers of your client's new book are enthusiastically directed) provide the key to unlock whatever confidentiality your client's use of pseudonyms in his new book purported to give Pfizer employees and others.¹ To the extent your violation of the Protective Order is not viewed by you or your client as sufficient reason to remove the Confidential documents from your website, perhaps the loss of whatever protection your client had hoped to gain from his use of pseudonyms will cause you to act promptly. Given that the book's official release date was yesterday, we suggest "promptly" should be construed as "immediately."

Dear Jon:

I write to follow up on my letter dated September 11, 2006. I thank you for your prompt attention in changing the web page, <http://greensavits.com/rosvpfizer.shtml>, which no longer directs the reader to documents covered by the Protective Order. However, the documents nevertheless remain available on your website by simply going directly to each individual document's website address (for example, one document is available at <http://greensavits.com/Apr18&21,2003.pdf>).

Accordingly, you continue to violate the Protective Order, which prohibits such disclosure. Please confirm at once that you have come into compliance with the Protective Order by actually removing the documents referenced in my September 11 letter from your firm's website, rather than simply removing links to these documents. In addition, please provide a copy of your server logs reflecting any access to or downloads of the aforementioned documents, requested in my September 11 letter, but heretofore unproduced, and confirm in writing that the documents covered by the Protective Order are no longer available on your website.
