COMMONWEALTH VS TAHIR O GARDNER

INFORMATION:

ON 1-28-2012, AT ABOUT 0015 HOURS, I WAS PARTNERED WITH CPL. WEALAND AND OFFICER ISHMAN. DURING THIS TIME, WE ATTEMPTED A TRAFFIC STOP IN THE 2300 BLK OF N 5TH ST ON A TAN IN COLOR FORD CONTOUR. AS WE EXITED OUR VEHICLE THE PASSENGER ATTEMPTED TO FLEE. 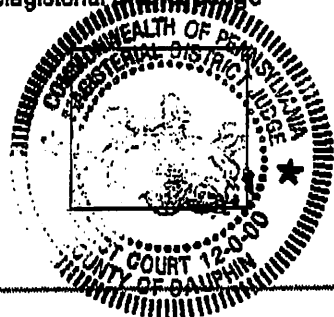
