1 5. That I have very poor eye sight and am physically weak compared to what I once 2 was. 3 That I am unable to work for a living or even drive any longer and am essentially 6. 4 disabled in these areas. 5 7 I do have a working brain and am able to think for myself without anyone telling 6 me what to do; however, I have no problem in receiving assistance from persons who are truly 7 interested in my well-being and best interests'. 8 8. I have authorized David Merritt to present to the court my wishes to do whatever 9 was needed to bring me back together with my husband. 10 9. I have been very depressed and stressed in not having communications with my 11 husband Gene and I took it upon myself to constantly call him every day until he finally began to 12 answer his phone to speak with me. 13 10. This court ordered for my "Conservator" (i.e. Stephen Pacheco), to make certain 14 that \$500 per week was available to me in my own checking account. See Exhibit A. 15 This has not been done at anytime from the time that this Court issued its order to 11. 16 now. 17 Sometime before April 22, 2013, Stephen cancelled by checking account, without 12. 18 forewarning me and without my knowledge or permission. 19 13. From the first time that I called him, after the restraining order, Gene told me that 20 he was not answering my phone calls because the TRO stated that he could not contact me, but 21 that he did not know what that meant until he learned in the library that the restraining order says 22 that he cannot initiate the contact, but he does have a right to answer his phone. 23 14. Before Gene and I were married at the end of 2012, we had lived together in my 24

1	15. Although all of this is very private and I should not have to divulge such things				
2	publicly, I can state that I have not met a kinder and gentler man than Gene, and this is what				
3	caused me to start liking then ultimately loving him.				
4	16. Gene has never abused me physically or financially.				
5	17. My son Stephen has been violently against my falling in love in my older years and				
6	has always acted with dislike and hatred towards Gene.				
7	18. Gene had tried to reason with Stephen by telling him that he was willing to submit				
8	to pre-nuptial agreement or otherwise relinquish any right to my property and estate.				
10	19. I witnessed Stephen reject these offers out of hand and showed that it was not the				
11	money but something else driving him to dislike and hate Gene, which may be due to the fact that				
12	Gene is African American.				
12	20. Stephen has directly told me that I am too old to be having Gene as my husband				
14	and flatly discriminates against me because of my age.				
15	21. Stephen has directly told me that I am now the child and that he is the adult who				
16	must always subject my desires and needs to what he believes is best for me.				
17	22. My knowledge about Stephen is one who never has been sensitive or able to				
18	sympathize with others and pretty much thinks only what is best for him and it is partly way he				
19	refuses to see or understand my best needs and interests'.				
20	23. I have never witnessed Stephen to show love towards me or actions which reflect				
21	that he truly cares what is best for me.				
22	24. I can no longer have a peaceful conversation with Stephen because any time I				
23	mention Gene and my desire and need to get back together with him, Stephen becomes verbally				
24	violent which is a direct abuse upon my mind and spirit.				
25	25. I have consistently spoken to this court's examiner, lawyers, my son and others				
26	regarding my estate and marriage to Marreon Gene Starks.

26. I have clearly expressed to them each that I have a clear mind and desire to make the decision to live my remaining days with Gene precisely because he has given more happiness then I actually ever experienced before with my deceased husband and otherwise.

Once I learned about these conservatorship proceedings, and spoke with all the actors playing in it, I have repeatedly asked, begged, ordered and otherwise requested for them to permit me to speak with the judge directly on the record so that the public record will show that I have sound mind and made the decisions to be with Gene based upon my own volition and was not tricked or wrongfully manipulated to be with Gene or marry him.

10 28. My son and Michael Desmarais are 100% against anyone who does not go along with their plan to take my money and are attacking anyone who is showing signs of helping me.

29. Michael Desmarais positively knows that I have a sound mind and wish to be with Gene, and that Stephen does not have my best interest at heart, but it appears that he has not represented to this court any of my needs, wishes or what is best for me.

30. I have and are in a state of depression because of this forced and illegal separation
from Gene, which even my mental doctor is aware of but it appears that non of this is being
considered by the court.

31. Since I have been talking to and expressing all my wishes to the court examiner.
 Michael Desmarais, Stephen and others, and the court still issued and maintains a restraining order
 against my husband Gene and I, I can only conclude that everyone currently involved in this
 Conservatorship affair does not have my best interests' at heart.

16 55. Stephen had initially called me saying that he was coming to get the car because his
 17 car was in the shop and that he needed my car in order to get around.

18 56. I first called Gene about this and David came on the line, then I asked them19 whether I had to give my car over to Stephen.

57. David told me that if it is in my name then I did not have to.

58. The week before, I had told David that I was willing to sell the car in order to raise
money so that I and Gene could hire a lawyer to fight the restraining order and other legal issues
arising from this.

59. So on Monday Stephen came with the scheme to get the car from me and when 1 told him no and held on to my keys, he tried to pry the keys from my hands then twisted my arm and wrist so violently that it left a clear bruise on my right hand.

Of course I do bruise, but not as severely as the markings left by Stephen Monday 2 and this is when I phoned Gene back and again told him, like I had been telling Gene for weeks. 3 that I was fearful of Stephen due to his growing violent behavior. 4 David asked me whether I felt that it was a need to call the police and I said yes. 61. 5 62. He asked me several more times to be clear and finally stated that he would call and 6 make a police report. 7 63. The police official and my care giver were witnesses of the results of Stephen's 8 assault upon me and promised to make certain that Stephen would not return and harm me. 9 I clearly explained to the officer my fears and facts regarding this and he reassured 64. 10 me that he would take care of it properly. 11 65. I then later learned that Gene and David went to police station as my witnesses to 12 confirm what they experienced and that Gene was taken into custody for violating restraining 13 order although it was I who was calling him and he never called me. 14 66. I need a Conservator who will not protect or be controlled by anyone's interests 15 other than mine. 16 67. I am attaching copy of Michael Desmarais Petition for Attorney's Fees and Costs 17 as evidence of his ill intent. 18 68. He is seeking to obtain over \$32,000 for doing the very things against my best 19 interests' and helping only the interests of Stephen. For personally hearing from me and 20 witnessing my clear state of mind and desires, but apparently not reporting such to this court 21 faithfully or honestly. No lawyer should be compensated for doing what has been done to me. 22

69. I am objecting to Desmarais being paid anything, because he has not honestly 23 represented my interests' before this court. 24

25 70. I request the court to remove Stephen Pacheco as conservator; eliminate the restraining order against Gene; find me a honest female lawyer to replace Michael Desmer 26
