The Conservatee, Beatrice Pachoco, comes before this Court pursuant to CCP 170.6 requesting Judge Cain to recuse himself from this conservatorship case and request the presiding judge to appoint a non-

biased judge therefrom, based on Conservatee's belief that she cannot get fair and impartial review or decisions from Judge Cain.

Conservatee began to become aware of Judge Cain's bias and prejudice after he conducted hearings to take control of her estate and person, which resulted in an involuntary separation from her new husband, and theretofore domestic partner, without summoning her before him or otherwise seeking to obtain input directly from her. Judge Cain seems to have either gone along with her son's plan to take away her basic rights, or he blindly accepted the self-serving and slanted evidence presented by Stephen Pacheco. Judge Cain took Stephen Pacheco's and his Michael Desmarais sides, without hearing or seeking to hear from Beatrice Pacheco herself before making such a serious and detrimental order against her and her interests'. The judge has subjected Conservatee to a very abusive son who has been failing to do what is in her best interests; refuses to even comply with the Judge's order to provide her monthly funds; verbally abusive; scheming and conniving against her; acting on the basis of racial discrimination against her husband and

physically assaulting her on April 22, 2013. Declaration of Beatrice Pacheco.

It appears that Judge Cain has made predeterminations against her husband based solely on the fabricated facts produced by Michael Demarias and Stephen Pacheco who are obviously only interested in getting at Conservatee's funds to unjustly enrich themselves, and do not have any interests of Conservatee in mind. *Ibid*.


Conservatee is in her right state of mind, although physically ailing, and Judge Cain failed or refused to do the most simple and basic inquiry into whether fraud was being perpetrated upon this Court and her. The Conservatee has not lost her faculties and was not being duped or abused by Mr Starks and so it appears that Judge Cain is incapable of being impartial since he has either brought his own racial or gender biases to this case, or has improperly taken the sides of those who has Conservatee's detriment in mind.

In support of this motion Conservatee submits the attached declaration in support of this disqualification and request for the Court to

assign another judge who does not maintain racial, gender or other biases which would prevent them from impartially investigating this matter.

Additionally, Conservatee authorizes David Merritt to present this

motion and declaration on her behalf to the court as a direct expression of her wishes and interests'.
