Bio-Sketches

President Marsha Howell Adams, PhD, RN, CNE, ANEF

Professor and Senior Associate Dean of Academic Programs, University of Alabama Capstone College of Nursing, Tuscaloosa

Marsha Howell Adams, who served on the NLN BOG as a governor at-large before becoming president-elect two years ago, chaired two task forces—the Nursing Education Standards Task Force and the Excellence in Nursing Education Task Force—responsible for developing and disseminating the *Hallmarks of Excellence in Nursing Education* and the *Excellence in Nursing Education Model*, key documents to advance NLN excellence initiatives in support of the NLN mission and core values. She first became active in the NLN in 1983; her League involvement has also included leadership roles in her state Constituent League, the Alabama League for Nursing, which she served as president, president-elect and secretary, as well as on numerous committees.

Through her practice background in rural health nursing at a hospital that served as a clinical site for nursing students attending the University of Alabama Capstone College of Nursing, Dr. Adams discovered her love of teaching, and its corollary, life-long learning. The lure of nursing education motivated her return to school at various stages in her career, first to her alma mater, UA-Birmingham, to earn the master's degree that qualified her to join the Capstone College faculty. She later earned her doctorate in education administration at UA-Birmingham and a post-doctorate in case management at UA-Tuscaloosa in the Capstone College.

For the past 10 years, Dr. Adams has served in an administrative capacity at the university, teaching advanced degree candidates and working with both graduate and undergraduate nursing students as an assistant dean. In her current role as senior associate dean of academic programs, she continues to teach nursing fundamentals through a service-learning project, KidCheck Plus. Each year, Dr. Adams supervises students' visitation to a rural school system to perform health screenings and physicals that provide the only opportunity, in many cases, for youngsters to have an annual exam. Her scholarly work, based on clinical research, has documented health disparities for patients suffering from obesity, Type 2 diabetes, and hypertension. She is proud, in particular, of having introduced nursing students to the science of nursing, where they have discovered how research can lay the foundation for implementing change that may positively impact health outcomes for individuals, within communities, and across the state.

President-Elect Anne Bavier, PhD, RN, FAAN

Professor of Nursing and Medicine, University of Connecticut School of Nursing, Storrs, Connecticut

Dean of the School of Nursing at the University of Connecticut since 2007, Anne Bavier recently transitioned to her current role there as professor of nursing and medicine. She came to U-Conn from St. Xavier University, where she had served as dean since 2004. Prior to that she was assistant dean for development, alumni, and external relations, and then assistant dean for planning and external relations at the Neil Hodgson Woodruff School of Nursing at Emory University in Atlanta. She also held teaching posts at St. Xavier, Emory, Yale University, and Georgia State University.

Dr. Bavier also brings to her new post at the NLN more than a dozen years of experience in leadership roles at federal health care agencies, including that of deputy director of the National Institutes of Health's Office of Research on Women's Health. There, she oversaw a \$17.5 million budget related to research on women's health; represented the agency on major federal policy committees; and led the development of new funding approaches to enhance research on women's health.

Among her many accomplishments over a varied, distinguished career have been encouraging faculty to increase their scholarly publication and presentations; increasing grant funding to the academic institutions under her watch and expanding aid to economically disadvantaged nursing students. At Emory University, for example, Dr. Bavier was instrumental in securing the largest single gift ever – \$5 million – and funding for the first endowed professorship in nursing.

Dr. Bavier received the first Edith Moore Copeland Award for Creativity from Sigma Theta Tau International. The award is the highest honor bestowed by this international nursing leadership society. Colleagues also elected her a Fellow of the American Academy of Nursing and to the Institute of Medicine of Chicago. She received the highest honors from both federal agencies where she worked: the National Institutes of Health Director's Award and the Administrator's Award from the Agency for Health Care Policy and Research.

Dr. Bavier earned her bachelor's degree from Duke University, her master's from Emory University, and her PhD from Duquesne University, all in nursing.

Secretary Joan Frey, EdD, RN, NEA-BC

Dean, Louisville Campus, Galen College of Nursing, Louisville, Kentucky

Joan Frey stepped into the position of secretary on the NLN Board of Governors, following the conclusion of a three-year term (2007-2010) — her second — as a governor-at-large. Dr. Frey's history of service on the BOG as well as her past involvement on NLN committees and councils, well prepared her to assume her leadership role.

Before she arrived at Galen in 2008, Dr. Frey built an impressive record in nursing education. She began as an adjunct faculty member at the Aultman Hospital School of Nursing in Canton, Ohio in 1987, rising to become director of the Aultman Health Foundation in 1991, with overall responsibility for the direction of the school. From 2003 to 2006, she oversaw the school's transition to a degree-granting college, becoming director of the Division of Nursing at Aultman College of Nursing and Health Sciences in 2004. In 2007, she was named director of campus, community, and public affairs, an executive position responsible for Aultman's external organizational education outreach, community relationships, grant writing, public relations, and the promotion and coordination of the Aultman Education Center. In that position, she also provided support for long-range planning and daily operations of the college. On the practice side, Dr. Frey has more than 28 years of experience in medical-surgical nursing, critical care step-down, dialysis, quality assurance, and head nurse roles.

A music major at the University of Illinois at Champaign-Urbana, where she earned a bachelor's of science degree in 1970, Dr. Frey returned to school to earn her ADN from Triton College in River Grove, Illinois in 1980; an MSN with a focus in nursing administration from University of Akron in Akron, Ohio in 1990; and a doctorate in educational leadership from Ashland University in Ashland, Ohio in 2005.
