#### **Plan Design**

Our plan design options are not a "standardized" retirement solution. We highly specialize in <u>cross</u> <u>testing</u>. Benefits of this type of plan design include higher contributions to business owners or employees in leadership roles, multiple allocation rates among employees, flexible employer contribution, heightened potential for FICA tax savings, and increased employee retention and recruiting.

#### **Fiduciary Oversight**

American Trust acts as a <u>full discretionary trustee</u>. Our services include plan document and investment oversight, administrative support, and our team:

- Reviews, drafts, maintains, and interprets the plan document
- Assists the annual audit
- Supports ERISA §404(c) compliance

As a §3(38) investment manager, American Trust is responsible for the selection, monitoring, and replacement of the plan investments. Our qualified Trust Committee oversees the investment management process by:

We offer participants a series of five portfolios to choose from based on their risk tolerance, and the portfolio management team makes adjustments for market trends and volatility.
