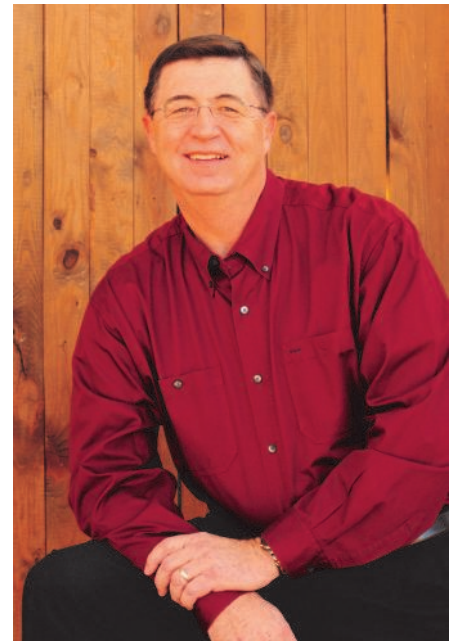

## The Cope 503 IRS Elimination Plan
