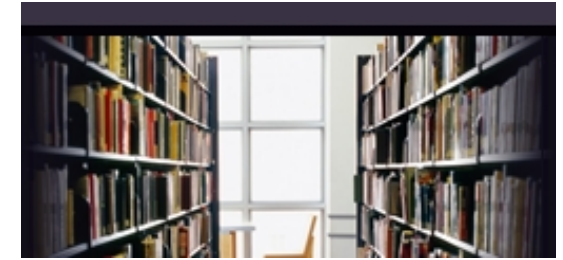


### What Makes Divorce Coaching Different from Other Coaching?
