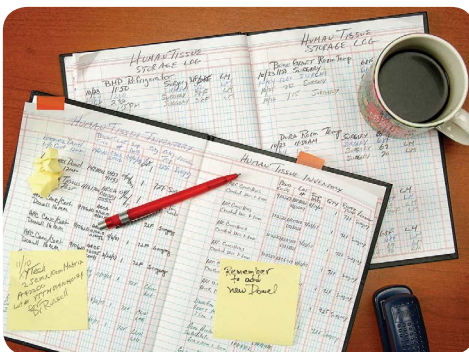
BENEFITS OF THE UDI RULE

- > The FDA believes that “identifying medical devices will strengthen safety” (1).
- > Use of the UDI in hospitals will “reduce medical errors” (2).
- > The UDI will provide a “standard and clear way to document device use in electronic medical records, clinical information systems, claim data sources and registries” (2).
- > Effective use of the UDI by healthcare facilities will allow them “to more effectively manage medical device recalls” improving patient safety (2).
- > “Provide a foundation for a global, secure, distribution chain, helping to address counterfeiting and diversion...” (2).

CHALLENGES IN HEALTHCARE

- > Up to **30% of surgical implants** are brought in the day of surgery with little or **no quality assurance oversight** on Rep delivered items.
- > 99% of recalls are **investigated manually – 105,000 medical device** products are recalled every year.
- > Hospitals **lose \$19 - \$27 billion** every year due to expiring or missing medical devices.
- > Lack of data sharing between MMIS systems and patient care systems (EHR) results in significant waste.
- > Hospitals **lack visibility into their medical device usage** and associated cost, limiting their ability to make informed decisions.
