The 246 hotel apartments will be developed with varying sizes, ranging between 36 sqm for studio apartments and 104 sqm for two-bedroom apartments. A speciality restaurant and lobby café will provide a variety of cuisine and guests will also be able to relax at a swimming pool, gymnasium, spa and beauty salon. Several shops and two meeting rooms complete the plans.

El Housein Limited, the owning company of Mövenpick Hotel Apartments Downtown Dubai, is also the owner of Mövenpick Hotel Les Berges Du Lac Tunis. Both properties are currently under construction. Fethi Neifer, the owner of El Housein Limited, said he is excited about the company's partnership with Mövenpick Hotels & Resorts. "We like the fact that Mövenpick has a clear strategy for expansion, which builds confidence and clarity. I am certain our two projects will benefit greatly by being managed with a focus on quality, high standards and consistent service."
