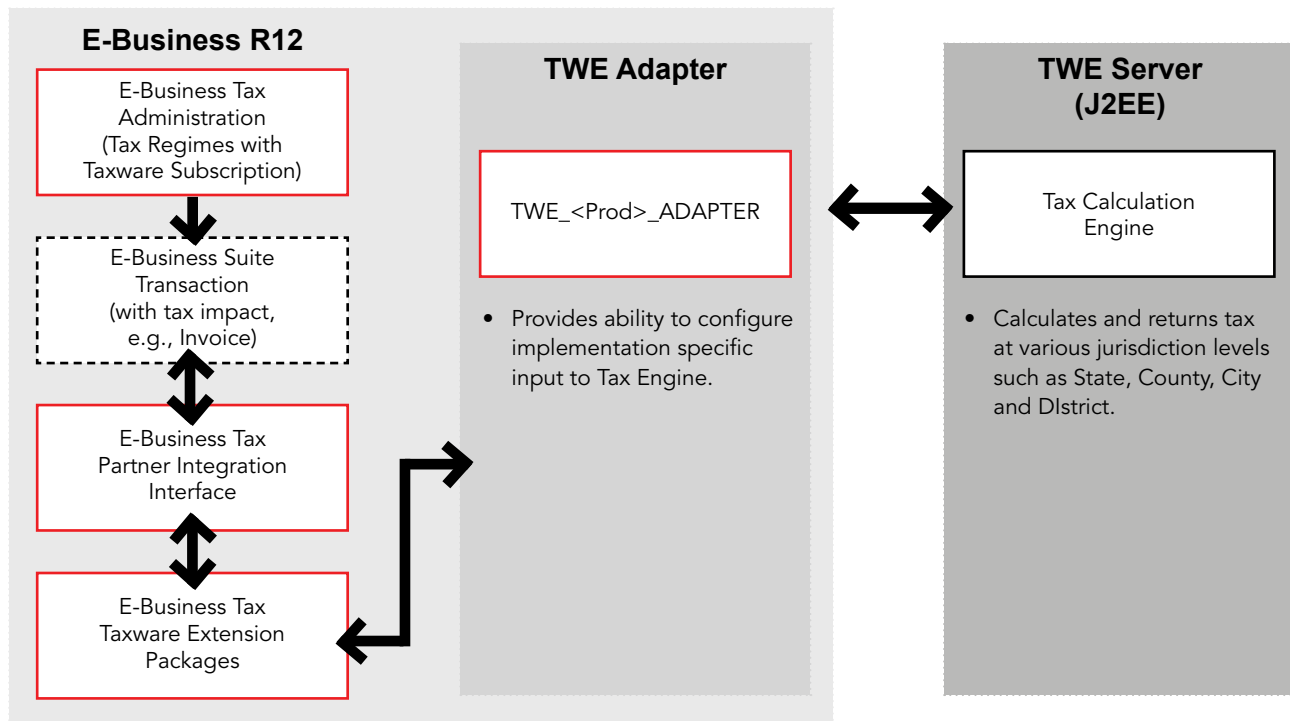

The TWE interface is comprised of a PL/SQL adapter that calls a Taxware SOAP service to invoke TWE for geocode lookup, tax calculation and reporting.

Order-to-Cash and Procure-to-Pay

TWE integrates with Oracle E-Business Suite 12.2 and uses the Oracle Receivables, Oracle Order Management, Oracle Purchasing and Oracle Payables modules to leverage the Tax Partner subscription method of Oracle E-Business Tax for third-party tax vendor integration.

Oracle Inventory

TWE integrates with the Oracle Inventory module in Oracle E-Business Suite to track the transactional data in Oracle Inventory and post the appropriate tax entries in the Oracle General Ledger module in the Oracle E-Business Suite. The accruals entries are audited in TWE and the corresponding entries are audited in Oracle General Ledger for the tax and expense accounts.
