Ticket to Work Incentives

The SSA's Ticket to Work program provides a significant range of incentives designed to support those who have received SSDI benefits and who want to re-enter the workforce. Some of the current program incentives include:

- **Trial Work Period (TWP)** – The TWP allows you to test your ability to work for at least nine months within a 60-month period. Full SSDI and Medicare benefits continue (regardless of earnings).
- **Continuation of Medicare** – You may continue your Medicare coverage for 93 months (more than seven years) after your trial work period.
- **Continuing Disability Reviews (CDRs)** – In many cases, you can receive protection or are exempt from medical CDRs, provided you make timely progress toward your employment goals.
- **Extended Period of Eligibility (EPE)** – After completing your trial work period, you have 36 months during which you can work and still receive benefits for any month your earnings are below \$1,090 per month (or \$1,820 if blind). This period does not require a new SSDI application.
- **Expedited Reinstatement** – If you experience a relapse of disability due to your original medical condition and become unable to work within five years after your EPE ends, you may ask to re-start your SSDI benefits immediately. This does not require a new SSDI application.
