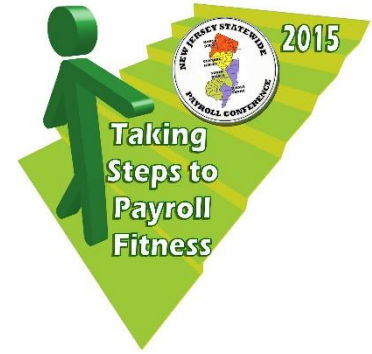

Candidate Requirements

- Minimum of three years of work experience in the payroll field.

How to Apply

Prepare your answers to the following questions in Word. Please be sure to include your name, company, title, phone number and email address.

(1) A list and brief description of accomplishments from the applicant, which documents:

A. Educational advancement

- Professional growth (i.e., certifications, etc.) (Maximum of 5 points)
- Personal growth (i.e., educational classes, etc.) (Maximum of 5 points)
- Organizational growth (i.e., staff development, corporate awareness, etc.) (Maximum of 5 points)

B. Involvement in process improvements within your job, department, or organization (i.e., cost savings, efficiency/productivity increases, etc.) (Maximum of 10 points)

(2) Personal essay

If awarded an education grant, describe how it would help you in the advancement of your payroll professional career. Limit your essay to one typed page of 50-100 words. (Maximum of 15 points)

(3) A letter of recommendation detailing why the nominee/applicant is a worthy candidate for an education grant. The letter must be signed by the person writing it and saved in PDF format. (Maximum of 10 points each)
