Specialized Sediment Removal

Excess sediment can adversely affect pump intakes and aeration units, and decrease holding capacity of facility ponds and impoundments.

Allied's approach to sediment removal is unique. Bulk sediment is removed utilizing a process that combines specialized SCUBA diving techniques, vacuum extraction, and a passive sediment dewatering system within geotextile containers.

Our process is ideal for:

- Fire water ponds
- Surface impoundments
- Dammed reservoirs
- Cooling water and process ponds
- Pump stations and equipment vaults
