#### Who is Darrell Castle?



1948 - born in Kingsport, Tennessee

1966 - graduated Ketron High School

1970 - B.S. in Political Science and History from East Tennessee State University

1971 - served in Viet Nam as a United States Marine Corps Combat Officer

1979 - Juris Doctorate from Memphis State (University of Memphis)

1984 - opens Darrell Castle and Associates law firm in Memphis, Tennessee

2008 - chosen to serve as Constitution Party Vice-presidential Nominee

2016 - chosen to serve as Constitution Party Presidential Nominee

Mr. Castle and his wife Joan currently reside in Germantown, Tennessee.

## **Military Service:**

Darrell came of age during the Viet Nam War. During his years at East Tennessee State University, he enrolled in the Reserve Officers Training Corps (ROTC) for two years and attended the Marine Corps Platoon Leaders class in Quantico, Virginia. Following graduation, he was commissioned as a 2nd Lieutenant in the United States Marine Corps. Darrell trained under then 1st Lieutenant, Oliver North. After graduation from Basic School, Darrell's unit received a unit citation for being deployed in five different theaters of operation at the same time. He was promoted to 1st Lieutenant and received orders to the Far East for 13 months. His service in Viet Nam followed a family military tradition; his oldest brother serving in the Army during World War II, another brother having served as a Marine in the Korean War.

War is a life-changing event and Darrell's experiences during those years contributed to his strong belief that war should not be entered into capriciously; and, that the decision to go to war must be made according to constitutional provisions. He firmly believes in upholding Article I Section 8 of the U.S. Constitution, which makes it clear that only Congress can declare war, and that those powers are not granted to the president. He left the Marine Corps a very different person than when he went in.

## **Legal Career:**

In 1984, Darrell opened a private firm, which later grew into Darrell Castle and Associates, based in Memphis, Tennessee. Since then, he has opened firms in Milwaukee, Wisconsin; Detroit, Michigan; Kansas City, Missouri; and St. Louis, Missouri. With over 25 years of legal experience, he has earned much respect. His current focus is on consumer bankruptcy and personal injury, but Darrell Castle and Associates also represents clients in the areas of social security/disability and workers' compensation. ## **Religion:**

Darrell has a strong Christian religious ethic. He has served as a deacon and deacon chairman in his local church. In 1998, Darrell and Joan stretched out their hand to serve others, and founded Mia's Children Foundation (www.miaschildren.org), a Christian mission in Bucharest, Romania which ministers to homeless gypsy children.

## **CAMPAIGN ISSUES:**

Darrell's Promise to America, ""If God raised me up and made me President of the United States, what I told the states, what I told you I would do, I will do, or die trying. So help me God." (Acceptance Speech, Salt Lake City, 16 April 2016)

- 1. **Adherence to the Constitution** "The Constitution is the charter of liberty for the American Republic. It is much more than just a piece of paper or just a legal document. It is evidence of the grand design the founders left us and it secures the rights that God granted to us. Adherence to the Constitution brings liberty and ignoring and denigrating it brings tyranny."
- 2. Withdraw from the United Nations "I believe that the United States (U.S.) should regain its sovereignty and chart its own course. This is not isolationism. The U.S. cannot remain isolated from the forces agitating today's world, which is so interrelated in trade, finance, instantaneous communications, etc. The very existence of the U.N. is an affront to liberty and human dignity. Many of the inherent rights in the US Constitution are superseded by the United Nations Charter, including the right of self-defense. We must free ourselves from the notion that the U.N. is vital to U.S. interests. It is not. If the American people do not understand these things, then it is imperative that we educate them."
- 3. **End the Federal Reserve System** "I would end the Federal Reserve's control of the United States' monetary system by repealing the Federal Reserve Act. Interest rates would no longer be tampered with, as lenders and borrowers would set their own rates. As a result, the country would return to a traditional and sensible money system so people could decide for themselves what kind of money they wanted to use. They could save it, spend it, or put any price they wanted on it if they wanted to lend it out."
- 4. **Agenda 21** "Private property rights are under assault in communities and rural areas across the nation as state and federal authorities move to enforce new planning development programs, particularly under the labels of Sustainable Development or Local Visioning. I would withdraw the federal government from such international, sovereignty destroying legislation. I would stop the federal government from manipulating local communities with handouts, and begin the process of handing control of their lives and property back to the local people."
- 5. **Pro-Life** "If you've ever made a statement that you will never vote for someone who is not pro-life, or who supports abortion, and if you are really serious about that statement, then you only have one choice in this election. I am the only candidate of any party that is 100% pro-life or even close to it."

# **Meet Scott Bradley:**



Currently an independent business owner, Scott N. Bradley was born and raised in Utah. He has worked tirelessly to serve his God, his family, and his country. From his earliest years he possessed an abiding love of America and her Constitution, which has led him to a close study of that document and the writings of the American Founding Fathers.

Scott served in the Utah Air National Guard before serving for two years as a missionary for his church. He returned to receive a Bachelor of Science degree, a Master's Degree in Public Administration, and a PhD in Constitutional Law. For thirteen years, Scott worked as an executive at AT&T, where he managed cutting-edge telecommunications projects and worked in all facets of corporate management; including strategic planning, and a leadership assignment responsible for delivery of secured communications for the U.S. Department of Defense (North American Air Defense Command—NORAD).

Scott then accepted an administrative position with Utah State University as a Department Head and Director for sixteen years.

Scott is Founder and Chairman of the Constitution Commemoration Foundation, a non-profit educational organization which seeks to foster increased understanding of the U. S. Constitution and encourages a return to proper government as understood and practiced at the time of America's Founding. He is also the author of the book and DVD/CD lecture series "To Preserve the Nation" and is host of a webinar series of the same name.

Scott has been active in the political process for more than 40 years, formerly serving at various times as a County Central Committee member, a Precinct Chairman, County Delegate, State Delegate, State Central Committee member, National Committee member, Platform Committee member, and as a National Executive Committee member. Scott ran twice for the United States Senate in an effort to better champion the United States Constitution and restore the principles upon which the United States was originally established.

Scott and his wife Tamara live in Northern, Utah. They are the parents of five children and eleven grandchildren. In the "tradition of the American Founding Fathers" he seeks to secure the Blessings of Liberty not only for himself and his posterity, but also for YOU and YOUR POSTERITY.

#### **CONSTITUTION PARTY INFORMATION:**

In 1992 a coalition of independent state parties united to form the U.S. Taxpayers Party at its first national convention in New Orleans, Louisiana. Among the notable convention speakers was former Congressman Ron Paul. The party's founder, Howard Phillips of Virginia, Chairman of the grass-roots lobby, the Conservative Caucus, was nominated to be the party's first candidate for President with retired Army Brigadier General Albion Knight of Maryland nominated as the party's first vice-presidential running mate. The US Taxpayer's Party secured ballot position in 21 states. Later, in 1999, the name was changed to the Constitution Party to better reflect the party's primary focus of reestablishing the American Constitutional Republic according to the Actual Intent of the Framers of the U.S. Constitution.
