NFI Breaks Ground on QPSI Headquarters in Florence

CHERRY HILL, N.J., 08/04/2016– Leading supply chain solutions provider, NFI, broke ground Thursday on a facility for industry-leading packaging provider, Quality Packaging Specialists International, LLC (QPSI) at NFI Park at Florence Crossings, N.J.

NFI is building the 377,440 square foot facility where QPSI will establish its new corporate headquarters and packaging supply chain center of excellence. QPSI will be the final company to join the complex, completing the build out of NFI Park at Florence Crossings with four total tenants at the popular location.


