The new hotel will be situated right by the S-Bahn and the planned ICE airport station and tram terminal stop.

On the culinary front, the hotel will have a 150 seat restaurant and a bar with seating for 100 guests.

For events and conferences, the design incorporates a 740-square metre ballroom in addition to several meeting rooms. When combined with the conference space at the Mövenpick Hotel Stuttgart Airport & Messe, just a short walk away, this will create the biggest meeting and event space in southern Germany, at almost 3,000 square metres.

“The new hotel will not only increase Mövenpick Hotels & Resorts’ profile in Germany, but also expand our European portfolio, which represents an important part of our corporate expansion strategy”, says Olivier Chavy, Mövenpick Hotels & Resorts’ new CEO.

There are currently eight Mövenpick hotels in Germany, three in the Netherlands, one in France, four in Turkey and five in Switzerland. Another hotel will also open in a premium location in Basel city centre in 2019.
