### THE PROBLEMS WE SEE

- One of the biggest problems is the centralization in the payments of different Cultural Events, Magic and Theater Shows, Artists and Performers Booking, and art related conventions, as well as stores, distributors and importers.
- 2. It is estimated that more than 800 million people in the world live in poverty and survive on less than \$ 1.6 per day. They have never had the chance to enjoy a Cultural Show that disconnects them from their reality and makes them feel the Magic of Theater and Art; for the first time in their lives. A ticket to a theater show can cost an average of 20-30 dollars (or more); which is equivalent to practically a month of survival for these people.
- 3. Surveys and studies conducted worldwide, indicate that the greatest fear that human being have (after the fear of dying), is speaking in public and establishing interpersonal relationships and there are very few people who can afford to study and learn to handle these issues.

"Using magic, art and culture as a tool, we will be able to handle these problems"


- Using the Ethereum Blockchain platform, TILX will become the first payment Cryptocurrency in the world of Magic and Arts in General, in any type of event, since it is a mechanism that guarantees security and confidence and it is used to decentralize the purchase / sale of goods or services related to Cultural Spaces and Art Tickets for any Magic Show or Theater Play around the world, Artists and Performers Booking, Musical Groups and Actors in any type of Corporate and Public Event; as well as for commercials, registration payments for Magic and Cultural Conventions worldwide and all similar Events; Distributors and Importers. TILX offers all of the above by removing centralization and intermediaries.
- 2. In order to be able to provide recreation spaces to extremely poor communities throughout the world and to patients of all ages, inside and outside hospitals and nursing homes, and others; through the artistic genre of Magic and Theater in General, we believe that generating joy, smiles and happiness in those people who need it and who are going through difficult times is a main part of the TILX ecosystem. Along with this, we can supply Food, Gifts and Magic Kits to continue expanding Art in each of these Events.





# **FUNDS DISTRIBUTION**







### Tokens Distribution:

#### ICO Contributors and Bonus – 57%:

A total of 52,500,000 TILXs will be issued, of which 21,000,000 (40%) will be destined to the Pre-ICO and the ICO; and 17% will be used to pay the Bonus. Investors interested in participating in this purchase and join the discounts; will be able to do it through the Ethereum Smart Contract that characterizes this Cryptocurrency.

#### <u>Reserve - 18%:</u>

This reserve will be used to maintain an active environment within the Company, part of the reserve may be purchased with a discount equal to or less than that obtained in the Pre-Sale and may be reinvested at Company's judgment; as well as to close necessary agreements that contribute to the realization of this Project.

#### Founders and Team – 15%:

This percentage will be destined for the founders and team members.

#### Advisory and Early Supporters – 5% and 5%:

A 10% total will be distributed among advisors and early sponsors who have supported and participated in the Project in one way or another (in equal parts).



### Funds Distribution:

#### Development and Research – 50%:

This percentage will be destined to execute the project: make shows to special communities, event planning, Magic Kits and gifts for the ones in need as well as the necessary platform and in agreements with Theaters, Artists, Online Tutors, Importers and Distributors.

<u>Marketing – 15%:</u> This percentage will be used for everything related to marketing.

Legal and Operational expenses – 12%: This percentage will be used for everything related to these expenses.

<u>**Team Incentives – 10%:**</u> This percentage will be used to encourage the team to close new deals.

<u>Reserve Fund – 8 %:</u> This percentage will be used as a reserve fund.

<u>Advisors Incentives – 5%:</u> This percentage will be used for advisors who want to work with us.



# **TERMINOLOGY**

<u>**Cryptocurrency</u>**: It is a digital asset designed to work as a medium of exchange that uses cryptography to secure transactions, to control the creation of additional units, and to verify the transfer of assets. Cryptocurrencies are classified as a subset of digital currencies and are also classified as a subset of alternative and virtual currencies.</u>

**Ethereum:** It is an open-source, public, blockchain-based distributed computing platform featuring smart contract (scripting) functionality. It provides a decentralized Turing-complete virtual machine, the Ethereum Virtual Machine (EVM), which can execute scripts using an international network of public nodes.

**<u>Blockchain</u>**: Is a continuously growing list of records, called blocks, which are linked and secured using cryptography.

**ERC-20:** It defines a common list of rules for all Ethereum tokens to follow; meaning that this particular token empowers developers of all types to accurately predict how new tokens will function within the larger Ethereum system.

**ICO (Initial Coin Offer)** It is a crowdfunding centered on cryptocurrency, which can be a source of capital for startup companies. In a ICO, some quantity is pre-allocated to investors in the form of tokens in exchanges for other cryptocurrencies such as BTC and ETH



**<u>E-learning</u>**: It is learning utilizing electronic technologies to access educational curriculum outside of a traditional classroom. In most cases, it refers to a course, program or degree delivered completely online.
