SOC 2 Type 2 is an authoritative standard created specifically to measure and test data security for technology and cloud computing service providers. Compliance is determined through a rigorous, third-party analysis that can include the five Trust Services Principles (TSP): security, availability, processing integrity, confidentiality and privacy. Over a period of six months to a year, an independent auditor reviews the structure and operational soundness of a service organization's controls, specific to IT and data center service providers. The audit accounts for the system of the data center, and the suitability of its design of controls, as reported by the company, as well as verification of an auditor's opinion on the operating effectiveness of the controls.
