Citrus CBD uses CBD derived from an evergreen species and citrus peels. Each ingredient is sustainable, and free of contaminants like pesticides, herbicides or other chemicals. “We really focused on sourcing,” continued Wolters. “Just like our customers, we value sustainability. When we first considered a non-hemp source of CBD, knowing it was environmentally sound was really important to us.”

While there has been surging interest in CBD, it is only now making its way to mainstream consumers. Historically CBD was derived from hemp or cannabis plants and accordingly is associated with THC in the minds of many consumers and lawmakers. In many states, and under the view of the Federal Government, cannabis-derived CBD is still considered a Schedule I controlled substance. Since it is derived from non-cannabis sources, Citrus CBD’s products are completely THC free and legal under the Controlled Substances Act.

Citrus CBD products are tested to be 99.7% pure and is packaged in 15mg capsules. The CBD compound used is both odorless, tasteless and bio-available. With its level of purity and its measured dosage, it’s possible for consumers to get consistent results with Citrus CBD capsules that would not be possible with powders or edible alternatives.
