



## HARDWARE AND SOFTWARE REQUIREMENTS

GEHRIMED is a web-based software. Access to GEHRIMED requires a client-based software installation on a desktop, laptop, or iPad. Both the web-based software and client software are frequently upgraded to align with evolving software architecture and security standards, and may require updates to customer devices to reserve adequate security and HIPAA compliance. No information is stored in the local iPad or computer. Local storage space is minimal and used only temporarily during sessions.

GEHRIMED requires internet connectivity to remain active, although occasional short disconnections are tolerated. Internet connectivity may be via a wired (for Windows) or wireless network or through a Cellular network card.
