Palmer and Novosis expect manufacturing assets to be ready by mid-2019, with an initial capacity of 6,000 metric tons per annum. The introductory product line will be comprised of traditional (brown) cashew particles with ambitions to grow and broaden its offerings in the future. Samples generated from a scaled-down pilot plant in the USA are ready immediately.

Novosis along with its sister company Admark Polycoats carry a quality-driven mindset from their widespread success in industrial coatings, epoxy curing agents and cardanol production, and Palmer will be sharing its industry-leading technology to guarantee strong production standards of friction particles. Palmer Novosis Green Technologies will be exhibiting at Asia Brake 2019 in Delhi from February 24<sup>th</sup> through the 26<sup>th</sup>.
