ISO 27001 is a globally recognized benchmark for the establishment and certification of a secure Information Security Management System (ISMS.) The standard specifies the requirements for establishing, implementing, operating, monitoring, reviewing, maintaining and improving a documented ISMS within the context of the organization's overall business risks.

SOC 2 Type I audits are based on the existing SysTrust and WebTrust principles. The purpose of a SOC 2 report is to evaluate an organization's information systems relevant to security, availability, processing integrity, confidentiality or privacy.
